# BOUNDARY MINIMAL MODELS AND THE ROGERS-RAMANUJAN IDENTITIES

#### Abstract

We determine when the irreducible modules $L\left(c_{p, q}, h_{m, n}\right)$ over the simple Virasoro vertex algebras $\operatorname{Vir}_{p, q}$, where $p, q \geq 2$ are relatively prime with $0<m<p$ and $0<n<q$, are classically free. It turns out this only happens with the boundary minimal models, i.e., with the irreducible modules over $\operatorname{Vir}_{2,2 s+1}$ for $s \in \mathbb{Z}_{+}$. We thus obtain a complete description of the classical limits of these modules in terms of the jet algebra of the corresponding Zhu $C_{2}$-algebra. Gordon's generalization of the Rogers-Ramanujan identities is used in the proof, and our results in turn provide a natural interpretation of these identities.


Keywords. Vertex algebras, boundary minimal models, Rogers-Ramanujan identities, quantum algebra, combinatorics.

## 0. Introduction

In [Li05], Li introduced a decreasing filtration $\left(F_{p} V\right)_{p \in \mathbb{Z}}$ on an arbitrary vertex algebra $V$. The associated graded space $\operatorname{gr}_{F}(V)$ with respect to this decreasing filtration carries the structure of a vertex Poisson algebra. Li also introduced a decreasing filtration $\left(F_{p} M\right)_{p \in \mathbb{Z}}$ for modules $M$ over a vertex algebra $V$ and showed that the associated graded space $\operatorname{gr}_{F}(M)$ is a module over the vertex Poisson algebra $\operatorname{gr}_{F}(V)$.

Given a commutative algebra $R$, the jet algebra $J R$ is constructed as the smallest differential algebra containing $R$. It was proved by Arakawa in [Ara12, Proposition 2.5.1] that there exists a natural surjection

J R_{V} \rightarrow \operatorname{gr}_{F}(V)
$$

of vertex Poisson algebras, where $R_{V}$ is the Zhu $C_{2}$-algebra of $V$ as defined in Zhu96. When this is an isomorphism, we say $V$ is classically free. For modules $M$ over the vertex algebra $V$, we also have a natural surjection

$$
J R_{V} \otimes_{R_{V}} R_{M} \rightarrow \operatorname{gr}_{F}(M)
$$

and we say $M$ is classically free if this is an isomorphism. One may in turn regard the classically free vertex algebra $V$ or $V$-module $M$, as a quantization of $J R_{V}$ or $J R_{V} \otimes_{R_{V}} R_{M}$, respectively.

The question of classical freedom of the simple Virasoro vertex algebra $\operatorname{Vir}_{p, q}$ was studied in (VEH21, and the answer is very simple. If $q>p \geq 2$ are relatively prime integers, then $\operatorname{Vir}_{p, q}$ is classically free if and only if $p=2$. The main objective of this article is to solve this problem for all irreducible modules over the vertex algebras $\operatorname{Vir}_{p, q}$, namely $L\left(c_{p, q}, h_{m, n}\right)$ for integers $m, n$ such that $0<m<p$ and $0<n<q$.

It turns out this problem is deeply connected with the Rogers-Ramanujan $q$-series identities and Gordon's generalization Gor61, namely

for $s \in \mathbb{Z}_{+}, i \in\{1, \ldots, s\}$, where

$$
\begin{aligned}
& G^{(s)}=(2 \min \{i, j\})_{i, j=1}^{s-1}, \\
& B_{j}^{(s)}=(0,0, \ldots, 0,1,2, \ldots, j)^{T} \quad \text { for } j=0,1, \ldots, s-1
\end{aligned}
$$

[^0]and $T$ denotes the transpose matrix.
The identity (0.1) has an interpretation in terms of integer partitions, as explained in And98, $\S 8]$. We represent a partition $\lambda$ either as a finite nonincreasing sequence of positive integers $\left[\lambda_{1}, \ldots, \lambda_{s}\right]$ or else as an infinite sequence $\left(f_{n}\right)_{n \in \mathbb{Z}_{+}}=\left[1^{f_{1}}, 2^{f_{2}}, \ldots\right]$ of nonnegative integers in which only finitely many of the $f_{n}$ are nonzero corresponding, the term $f_{n}$ being, of course, the number of times $n$ appears among the $\lambda_{i}$. We have a natural partial order $\leq$ on partitions given by $\left(g_{n}\right)_{n \in \mathbb{Z}_{+}} \leq\left(f_{n}\right)_{n \in \mathbb{Z}_{+}}$if $g_{n} \leq f_{n}$ for $n \in \mathbb{Z}_{+}$. A set $P$ of partitions is said to be a partition ideal if whenever $\left(f_{n}\right)_{n \in \mathbb{Z}_{+}} \in P$ and $\left(g_{n}\right)_{n \in \mathbb{Z}_{+}} \leq\left(f_{n}\right)_{n \in \mathbb{Z}_{+}}$, then $\left(g_{n}\right)_{n \in \mathbb{Z}_{+}} \in P$. We denote by $p(P, n)$ the number of partitions of $n$ that belong to $P$. We say two partition ideals $P_{1}$ and $P_{2}$ are equivalent, denoted by $P_{1} \sim P_{2}$, if $p\left(P_{1}, n\right)=p\left(P_{2}, n\right)$ for $n \in \mathbb{N}$.

Let $s \in \mathbb{Z}_{+}$, let $i \in\{1, \ldots, s\}$. Gordon's generalization of the Rogers-Ramanujan identities asserts

A^{s, i} \sim P^{s, i}
$$

where the partition ideals $A^{s, i}$ and $P^{s, i}$ are defined by:

\begin{aligned}
& A^{s, i}=\left\{\left(f_{n}\right)_{n \in \mathbb{Z}_{+}} \text {is a partition } \mid \text { for } n \in \mathbb{Z}_{+}, f_{n}>0 \text { implies } n \not \equiv 0, \pm i \bmod 2 s+1\right\}, \\
& R^{s, i}=\left\{\lambda \text { is a partition } \mid \lambda=\left[\lambda_{1}, \ldots, \lambda_{s}\right] \text { satisfies } \lambda_{1}-\lambda_{s} \leq 1 \text { or } \lambda=\left[1^{i}\right]\right\}, \\
& P^{s, i}=\text { the set of partitions that do not contain any partition in } R^{s, i} .
\end{aligned}
$$

As explained in And98, §8], $A^{s, i}$ is a partition ideal of order 1 while $P^{s, i}$ is a partition ideal of order 2. It is an open problem to characterize the equivalence classes of partitions ideals. For partition ideals of order 1, this problem is completely solved (see [And98, Theorem 8.4]).

In the context of representations of infinite dimensional Lie algebras and vertex algebras, the left-hand side of (0.1) is precisely the graded dimension, or character, of the irreducible Vir-module $M=L\left(c_{2,2 s+1}, h_{1, i}\right)$. Li's filtration is compatible with the grading, and so $\operatorname{gr}_{F}(M)$ acquires a second grading and hence a refined character, a series in two variables $(t, q)$. Our main theorems concern a modified version of this refined character and the intimate relation between the structure of $\operatorname{gr}_{F}(M)$ and the partition ideals $P^{s, i}$.

Theorem 0.1. The refined character of $L\left(c_{2,2 s+1}, h_{1, i}\right)$ is given by

\operatorname{ch}_{L\left(c_{2,2 s+1}, h_{1, i}\right)}(t, q)=q^{h_{1, i}}\left(\sum_{k=\left(k_{1}, \ldots, k_{s-1}\right) \in \mathbb{N}^{s-1}} t^{k B_{s-1}^{(s)}} \frac{q^{\frac{1}{2} k G^{(s)} k^{T}+k B_{s-i}^{(s)}}}{(q)_{k_{1}} \ldots(q)_{k_{s-1}}}\right)
$$

Theorem 0.2. The set

$$
\left\{L_{-\lambda_{1}} L_{-\lambda_{2}} \ldots L_{-\lambda_{m}}\left|c_{2,2 s+1}, h_{1, i}\right\rangle \mid \lambda=\left[\lambda_{1}, \ldots, \lambda_{m}\right] \in P^{s, i}\right\}
$$

is a vector space basis of $L\left(c_{2,2 s+1}, h_{1, i}\right)$.
Theorem 0.3. The boundary minimal models $L\left(c_{2,2 s+1}, h_{1, i}\right)$ are classically free as modules over the simple Virasoro vertex algebra $\operatorname{Vir}_{2,2 s+1}$ for $s \in \mathbb{Z}_{+}$and $i \in\{1, \ldots, s\}$. If $p, q>2$ then no irreducible $\operatorname{Vir}_{p, q^{-}}$module is classically free.

As a corollary, we obtain an explicit expression for the modules $\operatorname{gr}_{F}\left(L\left(c_{2,2 s+1}, h_{1, i}\right)\right)$ over the vertex Poisson algebra $\mathrm{gr}_{F}\left(\operatorname{Vir}_{2,2 s+1}\right)$.

This article is organized as follows. In \$1 we review Verma modules and set notations related to partitions. In \$2, we review certain filtrations of algebras and modules, the main example being the PBW filtration of a Lie algebra. In §3, we review modules over Lie algebras graded by a free abelian group of finite rank, the main example being Verma module $M(c, h)$ and the irreducible highest weight representation $L(c, h)$. In \$5, we introduce an explicit formula related to the normal product of a finite number of fields. In §6, we recall the irreducible modules over the simple Virasoro vertex algebras. In $\S 7$, we summarize the theory of filtrations of vertex algebras and their modules, with emphasis on explicit examples related to modules over the Virasoro Lie algebra. In $\mathbb{8}$, we recall the Zhu's algebra and the notion of classically freeness of
vertex algebras and their modules. In \$9, we prove our desired theorems. In the appendices, we recall notions related to Poisson algebras, jet algebras and vertex Poisson algebras.

## 1. Preliminaries and notation

All vector spaces and all algebras are over $\mathbb{C}$, the field of complex numbers, unless otherwise stated. The set of natural numbers $\{0,1, \ldots\}$ is denoted by $\mathbb{N}$, the set of integers is denoted by $\mathbb{Z}$, and the set of positive integers $\{1,2, \ldots\}$ is denoted by $\mathbb{Z}_{+}$.

First, we review the theory of representations of the Virasoro Lie algebra following [KRR13]. The Virasoro Lie algebra is a Lie algebra given by

$$
\text { Vir }=\bigoplus_{n \in \mathbb{Z}} \mathbb{C} L_{n} \oplus \mathbb{C} C
$$

These elements satisfy the following commutation relations:

$$
\begin{aligned}
{\left[L_{m}, L_{n}\right] } & =(m-n) L_{m+n}+\delta_{m,-n} \frac{m^{3}-m}{12} C \quad \text { for } m, n \in \mathbb{Z} \\
{[\operatorname{Vir}, C] } & =0
\end{aligned}
$$

Let $c, h \in \mathbb{C}$. We set Vir ${ }^{\geq}=\bigoplus_{n \in \mathbb{N}} \mathbb{C} L_{n} \oplus \mathbb{C} C$. We make the subalgebra Vir ${ }^{\geq}$of Vir act on $\mathbb{C}$ as follows:

$$
L_{n} 1=0 \text { for } n \in \mathbb{Z}_{+}, L_{0} 1=h \text { and } C 1=c .
$$

The Verma representation of Vir with highest weight $(c, h)$ is defined as

$$
M(c, h)=\operatorname{Ind}_{\operatorname{Vir} \geq}^{\mathrm{Vir}}(\mathbb{C})=U(\text { Vir }) \otimes_{U(\mathrm{Vir} \geq)} \mathbb{C},
$$

where Vir acts by left multiplication. We take $|c, h\rangle=1 \otimes 1$ as highest weight vector.
A composition (of $n \in \mathbb{N}$ ) is a sequence $\lambda=\left[\lambda_{1}, \ldots, \lambda_{m}\right]$ such that $\lambda_{i} \in \mathbb{Z}_{+}$for $i=1, \ldots, m$ (and $\lambda_{1}+\cdots+\lambda_{m}=n$ ). We also consider the empty composition $\emptyset$, which is the unique composition of 0 . Given a composition $\lambda=\left[\lambda_{1}, \ldots, \lambda_{m}\right]$ and a permutation $\sigma \in S_{m}$, we define the composition

$$
\lambda \sigma=\left[\lambda_{\sigma(1)}, \ldots, \lambda_{\sigma(m)}\right] .
$$

For a composition $\lambda=\left[\lambda_{1}, \ldots, \lambda_{m}\right]$, we define

$$
L_{\lambda}=L_{-\lambda_{1}} \ldots L_{-\lambda_{m}} \in U(\mathrm{Vir})
$$

the length of $\lambda$ as

$$
\operatorname{len}(\lambda)=m
$$

the weight of $\lambda$ as

$$
\Delta(\lambda)=\lambda_{1}+\cdots+\lambda_{m}
$$

and

$$
p_{\lambda}=L_{-\lambda_{1}} \ldots L_{-\lambda_{m}} \in \mathbb{C}\left[L_{-1}, L_{-2}, \ldots\right] .
$$

For a composition $\lambda$ with exactly $m$ elements greater than 1 and exactly $n$ elements equal to 1 , we define $\lambda^{\prime}$ as the composition obtained from $\lambda$ by removing all 1 s . We define the conformal length of $\lambda$ as

$$
\operatorname{clen}(\lambda)=2 m+n
$$

and

$$
u_{\lambda}=p_{\lambda^{\prime}} L_{-1}^{n} \in \bigoplus_{k \in \mathbb{N}} \mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right] L_{-1}^{k}
$$

A partition (of $n \in \mathbb{N}$ ) is a composition $\lambda=\left[\lambda_{1}, \ldots, \lambda_{m}\right]$ (of $n$ ) such that $\lambda_{1} \geq \cdots \geq \lambda_{m}$. The notation $\lambda \vdash$ means $\lambda$ is a partition, and for $n \in \mathbb{N}$, the notation $\lambda \vdash n$ means $\lambda$ is a partition of $n$. This notation also tacitly assumes that $\lambda$ is a partition and not just a composition.

Given a composition $\lambda$ of length $m$, there is a unique partition $\operatorname{prt}(\lambda)$ obtained by reordering $\lambda$, i.e., by considering all $\lambda \sigma$ for $\sigma \in S_{m}$.

By the PBW theorem, the set

$$
\left\{L_{\lambda}|c, h\rangle \mid \lambda \vdash\right\}
$$

is a vector space basis of $M(c, h)$. The representation $M(c, h)$ has a unique maximal proper subrepresentation $J(c, h)$, and the quotient

$$
L(c, h)=M(c, h) / J(c, h)
$$

is the irreducible highest weight representation of Vir with highest weight $(c, h)$.

## 2. Modules over algebras with a filtration

Let $A$ be an associative (not necessarily commutative) algebra with unit 1 and filtration $\left(A^{p}\right)_{p \in \mathbb{Z}}$ such that:
(i) $A^{p}=0$ for $p<0$;
(ii) $1 \in A^{0}$;
(iii) $A^{0} \subseteq A^{1} \subseteq \ldots$;
(iv) $A=\bigcup_{p \in \mathbb{N}} A^{p}$;
(v) $A^{p} A^{q} \subseteq A^{p+q}$ for $p, q \in \mathbb{Z}$.

Let

$$
\operatorname{gr}(A)=\bigoplus_{p \in \mathbb{N}} A^{p} / A^{p-1}
$$

be the associated graded vector space. The vector space $\operatorname{gr}(A)$ is an associative algebra with unit and multiplication given as follows. For $p, q \in \mathbb{N}, a \in A^{p}$ and $b \in A^{q}$, we set

$$
\gamma^{p}(a) \gamma^{q}(b)=\gamma^{p+q}(a b),
$$

where $\gamma^{p}: A^{p} \rightarrow \operatorname{gr}(A)$ is the principal symbol map, which is the composition of the natural maps $A^{p} \rightarrow A^{p} / A^{p-1}$ and $A^{p} / A^{p-1} \hookrightarrow \operatorname{gr}(A)$. The unit of $\operatorname{gr}(A)$ is $\gamma^{0}(1)$.

Let $\partial$ be a derivation of $A$ respecting the filtration $\left(A^{p}\right)_{p \in \mathbb{Z}}$, i.e., it satisfies:
(i) $\partial(a b)=\partial(a) b+a \partial(b)$ for $a, b \in A$;
(ii) $\partial\left(A^{p}\right) \subseteq A^{p}$ for $p \in \mathbb{Z}$.

We can define

$$
\begin{aligned}
& \partial: \operatorname{gr}(A) \rightarrow \operatorname{gr}(A), \\
& \partial\left(\gamma^{p}(a)\right)=\gamma^{p}(\partial(a)) \quad \text { for } p \in \mathbb{Z} \text { and } a \in A^{p},
\end{aligned}
$$

and it is a derivation of $\operatorname{gr}(A)$.
Example 2.1 (PBW filtration of $U(\mathfrak{g})$ ). Let $\mathfrak{g}$ be a Lie algebra. The PBW filtration of $U(\mathfrak{g})$, the universal enveloping algebra of $\mathfrak{g}$, is given by

$$
U(\mathfrak{g})^{p}=\operatorname{span}\left\{x_{1} x_{2} \ldots x_{s} \mid s \leq p, x_{1}, \ldots, x_{s} \in \mathfrak{g}\right\} \quad \text { for } p \in \mathbb{Z}
$$

This filtration clearly satisfies axioms (i)-(v) above, and $\operatorname{gr}(U(\mathfrak{g}))$ is naturally isomorphic to $S(\mathfrak{g})$, the symmetric algebra of $\mathfrak{g}$, which is a polynomial algebra (see [Dix96, §2] for details). Furthermore, if $\partial$ is a derivation of $\mathfrak{g}$ as a Lie algebra, then we can extend $\partial$ to a derivation of $U(\mathfrak{g})$, and it respects the PBW filtration. Thus, it defines a derivation $\partial: \operatorname{gr}(U(\mathfrak{g})) \rightarrow \operatorname{gr}(U(\mathfrak{g}))$.

Let $M$ be an $A$-module with filtration $\left(M^{p}\right)_{p \in \mathbb{Z}}$ such that:
(i) $M^{p}=0$ for $p<0$;
(ii) $M^{0} \subseteq M^{1} \subseteq \ldots$;
(iii) $M=\bigcup_{p \in \mathbb{N}} M^{p}$;
(iv) $A^{p} M^{q} \subseteq M^{p+q}$ for $p, q \in \mathbb{Z}$.

Let

$$
\operatorname{gr}(M)=\bigoplus_{p \in \mathbb{N}} M^{p} / M^{p-1}
$$

be the associated graded vector space.

Then $\operatorname{gr}(M)$ is a $\operatorname{gr}(A)$-module with operations given as follows. For $p, q \in \mathbb{N}, a \in A^{p}$ and $u \in M^{q}$, we set

$$
\gamma^{p}(a) \gamma_{M}^{q}(u)=\gamma_{M}^{p+q}(a u),
$$

where $\gamma_{M}^{p}: M^{p} \rightarrow \operatorname{gr}(M)$ is the principal symbol map, which is the composition of the natural maps $M^{p} \rightarrow M^{p} / M^{p-1}$ and $M^{p} / M^{p-1} \hookrightarrow \operatorname{gr}(M)$.

The category of modules over $A$ with the given filtration $\left(A^{p}\right)_{p \in \mathbb{Z}}$ is given by modules $M$ with filtration $\left(M^{p}\right)_{p \in \mathbb{Z}}$ satisfying conditions (i)-(iv) above. A homomorphism $f: M \rightarrow N$ must satisfy $f\left(M^{p}\right) \subseteq N^{p}$ for $p \in \mathbb{Z}$. This category is denoted by $A$-Mod (the filtration being suppressed from the notation).

If $f: M \rightarrow N$ is a homomorphism of $A$-modules, then

$$
\begin{aligned}
& \operatorname{gr}(f): \operatorname{gr}(M) \rightarrow \operatorname{gr}(N), \\
& \operatorname{gr}(f)\left(\gamma_{M}^{p}(u)\right)=\gamma_{N}^{p}(f(u)) \quad \text { for } p \in \mathbb{N} \text { and } u \in M^{p}
\end{aligned}
$$

defines a homomorphism of $\operatorname{gr}(A)$-modules. Therefore, we obtain a functor

$$
\operatorname{gr}: A-\operatorname{Mod} \rightarrow \operatorname{gr}(A) \text {-Mod. }
$$

From now on, some subscripts or superscripts will be omitted, so for example $\gamma_{M}^{p}$ simplifies to $\gamma^{p}$.

## 3. Modules over $Q$-Graded Lie algebras

In this section, we follow [IK11, §2]. Let $\Gamma$ be an abelian group. For a $\Gamma$-graded vector space $V=\bigoplus_{\alpha \in \Gamma} V^{\alpha}$, we set $\operatorname{supp}(V)=\left\{\alpha \in \Gamma \mid V^{\alpha} \neq 0\right\}$.

A $\Gamma$-graded Lie algebra is a Lie algebra $\mathfrak{g}=\bigoplus_{\alpha \in \Gamma} \mathfrak{g}^{\alpha}$ such that

$$
\left[\mathfrak{g}^{\alpha}, \mathfrak{g}^{\beta}\right] \subseteq \mathfrak{g}^{\alpha+\beta} \quad \text { for } \alpha, \beta \in \Gamma .
$$

Let $Q$ be a free abelian group of finite rank $r$, and let $\mathfrak{g}$ be a Lie algebra with a commutative subalgebra $\mathfrak{h}$. We say a pair $(\mathfrak{g}, \mathfrak{h})$ is a $Q$-graded Lie algebra if it satisfies the following:
(i) $\mathfrak{g}=\bigoplus_{\alpha \in Q} \mathfrak{g}^{\alpha}$ is $Q$-graded, $\mathfrak{h}=\mathfrak{g}^{0}$, and $\operatorname{supp}(\mathfrak{g})$ generates $Q$;
(ii) We have a homomorphism $\pi_{Q}: Q \rightarrow \mathfrak{h}^{*}, \alpha \mapsto \lambda_{\alpha}$ such that

$$
[h, x]=\lambda_{\alpha}(h) x \quad \text { for } h \in \mathfrak{h} \text { and } x \in \mathfrak{g}^{\alpha} ;
$$

(iii) For $\alpha \in Q, \operatorname{dim}\left(\mathfrak{g}^{\alpha}\right)<\infty$;
(iv) There exists a basis $\left(\alpha_{i}\right)_{i=1}^{r}$ of $Q$ such that for $\alpha \in \operatorname{supp}(\mathfrak{g})$,

$$
\alpha \in \sum_{i=1}^{r} \mathbb{Z}_{\geq 0} \alpha_{i} \text { or } \alpha \in \sum_{i=1}^{r} \mathbb{Z}_{\leq 0} \alpha_{i} .
$$

The condition (iv) implies that a $Q$-graded Lie algebra admits a triangular decomposition

$$
\mathfrak{g}=\mathfrak{g}^{-} \oplus \mathfrak{h} \oplus \mathfrak{g}^{+},
$$

where $Q^{+}=\sum_{i=1}^{r} \mathbb{Z}_{\geq 0} \alpha_{i}$ and

$$
\mathfrak{g}^{ \pm}=\bigoplus_{ \pm \alpha \in Q^{+} \backslash\{0\}} \mathfrak{g}^{\alpha} .
$$

For later use, we set $\mathfrak{g}^{\geq}=\mathfrak{h} \oplus \mathfrak{g}^{+}$and $\mathfrak{g}^{\leq}=\mathfrak{g}^{-} \oplus \mathfrak{h}$.
Example 3.1. We set $Q=\mathbb{Z}, \mathfrak{h}=\mathbb{C} L_{0} \oplus \mathbb{C} C$, $\operatorname{Vir}^{n}=\mathbb{C} L_{n}$ for $n \in \mathbb{Z} \backslash\{0\}$ and

$$
\begin{aligned}
\pi_{Q}: Q & \rightarrow \mathfrak{h}^{*}, \\
\pi_{Q}(n) & =\left(L_{0} \mapsto-n, C \mapsto 0\right) .
\end{aligned}
$$

Then $(\operatorname{Vir}, \mathfrak{h})$ is readily seen to be a $\mathbb{Z}$-graded Lie algebra. We take 1 as the basis of $Q$, so $Q^{+}=\mathbb{N}$. We can verify that $\operatorname{ad}\left(L_{-1}\right)$ is a derivation of Vir satisfying ad $\left(L_{-1}\right)\left(\operatorname{Vir}^{-}\right) \subseteq \operatorname{Vir}^{-}$. Therefore, $\operatorname{gr}\left(U\left(\operatorname{Vir}^{-}\right)\right) \cong \mathbb{C}\left[L_{-1}, L_{-2}, \ldots\right]$ has a derivation given by $\partial\left(L_{-n}\right)=(n-1) L_{-n-1}$ for $n \in \mathbb{Z}_{+}$.

Let $\Gamma$ be an abelian group, and let $\mathfrak{g}=\bigoplus_{\alpha \in \Gamma} \mathfrak{g}^{\alpha}$ be a $\Gamma$-graded Lie algebra. A $\mathfrak{g}$-module $M=\bigoplus_{\alpha \in \Gamma} M^{\alpha}$ is $\Gamma$-graded if

$$
\mathfrak{g}^{\alpha} M^{\beta} \subseteq M^{\alpha+\beta} \quad \text { for } \alpha, \beta \in \Gamma .
$$

An $\mathfrak{h}$-module $M$ is $\mathfrak{h}$-diagonalizable if

$$
M=\bigoplus_{\lambda \in \mathfrak{h}^{*}} M_{\lambda},
$$

where

$$
M_{\lambda}=\{u \in M \mid \text { for } h \in \mathfrak{h}, h u=\lambda(h) u\} .
$$

An $\mathfrak{h}$-diagonalizable module $M$ is called $\mathfrak{h}$-semisimple if

$$
\operatorname{dim}\left(M_{\lambda}\right)<\infty \quad \text { for } \lambda \in \mathfrak{h}^{*} .
$$

A $(\mathfrak{g}, \mathfrak{h})$-module is an $\mathfrak{h}$-diagonalizable $\mathfrak{g}$-module. From now on, we assume that $\pi_{Q}$ is injective.
The character of a semisimple $(\mathfrak{g}, \mathfrak{h})$-module $M$ is given by

$$
\operatorname{ch}_{M}(q)=\sum_{\lambda \in \mathfrak{h}^{*}} \operatorname{dim}\left(M_{\lambda}\right) q^{\lambda} .
$$

The category $\mathcal{C}_{(\mathfrak{g}, \mathfrak{h})}$ is the category whose objects are $\mathfrak{h}^{*}$-graded $(\mathfrak{g}, \mathfrak{h})$-modules and for $M, N \in$ $\mathcal{C}_{(\mathfrak{g}, \mathfrak{h})}, \operatorname{Hom}_{\mathcal{C}_{(\mathfrak{g}, \mathfrak{l})}}(M, N)=\operatorname{Hom}_{\mathfrak{g}}(M, N)$ (Lie algebra module homomorphisms).

Remark 3.2. If $f \in \operatorname{Hom}_{\mathfrak{g}}(M, N)$, then $f$ respects the $\mathfrak{h}^{*}$-grading automatically because for $u \in M_{\lambda}$ and $h \in \mathfrak{h}, h f(u)=f(h u)=f(\lambda(h) u)=\lambda(h) f(u)$.

We can introduce a partial order on $Q$ as follows

$$
\lambda_{1} \leq \lambda_{2} \Longleftrightarrow \text { there exists } \gamma \in Q^{+} \text {such that } \lambda_{2}-\lambda_{1}=\pi_{Q}(\gamma)
$$

Since $\pi_{Q}$ is assumed to be injective, we can abuse notation and write $\lambda_{2}-\lambda_{1}=\gamma \in Q$.
We now define the full subcategory $\mathcal{C}_{(\mathfrak{g}, \mathfrak{h})}^{\lambda \geq}$ by considering the objects $M \in \mathcal{C}_{(\mathfrak{g}, \mathfrak{h})}$ such that $M_{\mu}=0$ if $\lambda \nsupseteq \mu$.
Example 3.3. When considering the $\mathbb{Z}$-graded Virasoro Lie algebra (Vir, $\mathfrak{h}$ ), where $\mathfrak{h}=\mathbb{C} L_{0} \oplus \mathbb{C} C$, we identify $\mathfrak{h}^{*}$ with $\mathbb{C}^{2}$ as $\lambda=(c, h)$ if $\lambda(C)=c$ and $\lambda\left(L_{0}\right)=h$. We are mainly interested in the highest weight modules $M(c, h)$ and $L(c, h)$ of the Virasoro Lie algebra. In this case, $\left(c_{2}, n_{2}\right) \geq$ $\left(c_{1}, n_{1}\right)$ if and only if $c_{1}=c_{2}$ and $n_{1}-n_{2} \in \mathbb{N}$. If this happens, $\left(c_{2}, n_{2}\right)-\left(c_{1}, n_{1}\right)=n_{1}-n_{2}$.

## 4. The refined character

Let $(\mathfrak{g}, \mathfrak{h})$ be a $\mathbb{Z}$-graded Lie algebra, let $\lambda \in \mathfrak{h}^{*}$, and let $M \in \underset{(\underline{\mathfrak{g}, \mathfrak{h})}}{\lambda \geq}$. The $P B W$ filtration of $M$ is given by

$$
M^{p}=\left\{a u \mid q \in \mathbb{N}, \mu \leq \lambda, a \in U\left(\mathfrak{g}^{-}\right)^{q}, u \in M_{\mu}, q+\lambda-\mu \leq p\right\} \quad \text { for } p \in \mathbb{Z}
$$

This filtration clearly satisfies axioms (i)-(iv) of $\mathbb{2} 2$ with $U\left(\mathfrak{g}^{-}\right)$in place of $A$, and $\operatorname{gr}(M)$ becomes a $\operatorname{gr}\left(U\left(\mathfrak{g}^{-}\right)\right)$-module.

If $f: M \rightarrow N$ is a homomorphism, where $M, N \in \mathcal{C}_{(\mathfrak{g}, \mathfrak{h})}^{\lambda \geq}$, then

$$
\begin{aligned}
& \operatorname{gr}(f): \operatorname{gr}(M) \rightarrow \operatorname{gr}(N), \\
& \operatorname{gr}(f)\left(\gamma_{M}^{p}(u)\right)=\gamma_{N}^{p}(f(u)) \quad \text { for } p \in \mathbb{N} \text { and } u \in M^{p}
\end{aligned}
$$

defines a homomorphism of $\operatorname{gr}\left(U\left(\mathfrak{g}^{-}\right)\right)$-modules. Therefore, we obtain a functor

$$
\operatorname{gr}: \mathcal{C}_{(\mathfrak{g}, \mathfrak{h})}^{\lambda \geq} \rightarrow \operatorname{gr}\left(U\left(\mathfrak{g}^{-}\right)\right) \text {-Mod. }
$$

Remark 4.1. Let $M, N \in \mathcal{C}_{(\mathfrak{g}, \mathfrak{h})}^{\lambda \geq}$, and let $f: M \rightarrow N$ be a homomorphism. By Remark 3.2, $f$ respects the $\mathfrak{h}^{*}$-grading, and this implies $f\left(M^{p}\right) \subseteq N^{p}$.

Example $4.2(\operatorname{gr}(M(c, h)))$. We pick a highest weight $(c, h)$. By [Dix96, §2], we have a natural isomorphism

$$
\begin{aligned}
\operatorname{gr}(M(c, h)) & \xrightarrow{ } \rightarrow \mathbb{C}\left[L_{-1}, L_{-2}, \ldots\right] \cong \operatorname{gr}\left(U\left(\operatorname{Vir}^{-}\right)\right), \\
\gamma^{\operatorname{len}(\lambda)}\left(L_{\lambda}|c, h\rangle\right) & \mapsto p_{\lambda} \quad \text { for } \lambda \text { a composition. }
\end{aligned}
$$

In this article, we are interested in the refined character of $M \in \mathcal{C}_{(\mathfrak{g}, \mathfrak{h})}^{\lambda \geq}$, where $M$ is semisimple, defined to be

$$
\operatorname{ch}_{M}(t, q)=\sum_{p \in \mathbb{N}} \sum_{\lambda \in \mathfrak{h}^{*}} \operatorname{dim}\left(\gamma^{p}\left(M^{p} \cap M_{\lambda}\right)\right) t^{p} q^{\lambda},
$$

By axiom (iii) of $A$-modules given in $\$ 2$, we have

$$
\operatorname{ch}_{M}(1, q)=\operatorname{ch}_{M}(q) .
$$

Example $4.3\left(\operatorname{ch}_{M(c, h)}(t, q)\right)$. We consider the $\mathbb{Z}$-graded Virasoro Lie algebra (Vir, $\left.\mathbb{C} L_{0} \oplus \mathbb{C} C\right)$. For the Verma representation $M(c, h)$, we have:

$$
\begin{aligned}
\operatorname{ch}_{M(c, h)}(t, q) & =\frac{q^{h}}{\prod_{k \in \mathbb{Z}_{+}}\left(1-t q^{k}\right)} \\
\operatorname{ch}_{M(c, h)}(q) & =\frac{q^{h}}{\prod_{k \in \mathbb{Z}_{+}}\left(1-q^{k}\right)}=\frac{q^{h}}{(q)_{\infty}}
\end{aligned}
$$

Example $4.4\left(\operatorname{ch}_{L(1 / 2,0)}(t, q)\right)$. In AVEH22], the refined character of the Virasoro minimal model $\operatorname{Vir}_{3,4}=L(1 / 2,0)$, also known as the Ising model, is computed explicitly. Interestingly, this character is connected to Nahm sums for the matrix $\left(\begin{array}{c}8 \\ 3 \\ 3\end{array}\right)$ (see Nah07) and can be explicitly expressed as

$$
\operatorname{ch}_{L(1 / 2,0)}(t, q)=\sum_{k_{1}, k_{2} \in \mathbb{N}} t^{2 k_{1}+k_{2}} \frac{q^{4 k_{1}^{2}+3 k_{1} k_{2}+k_{2}^{2}}}{(q)_{k_{1}}(q)_{k_{2}}}\left(1-q^{k_{1}}+q^{k_{1}+k_{2}}\right),
$$

where $(q)_{k}=\prod_{j=1}^{k}\left(1-q^{j}\right) \in \mathbb{C}[q]$ denotes the $q$-Pochhammer symbol.
Remark 4.5. Let $V$ be an $\mathbb{N}$-graded conformal vertex algebra, and let $M$ be an $h+\mathbb{N}$-graded $V$-module. It is worth noting that the PBW filtration $\left(M^{p}\right)_{p \in \mathbb{Z}}$ and the standard filtration $\left(G^{p} M\right)_{p \in \mathbb{Z}}$, as introduced in [Sal24], are different. Therefore, the associated graded objects $\operatorname{gr}(M)$ and $\operatorname{gr}^{G}(M)$ and the refined characters $\mathrm{ch}_{M}(t, q)$ and $\operatorname{ch}_{\mathrm{gr}^{G}(M)}(t, q)$ are both different. For example, for a highest weight $(c, h)$,

$$
\operatorname{ch}_{\mathrm{gr}^{G}(M(c, h))}(t, q)=\frac{q^{h}}{(1-t q) \prod_{k \geq 2}\left(1-t^{2} q^{k}\right)}
$$

We pick a highest weight $(c, h)$. We have a natural epimorphism

$$
\begin{aligned}
\pi_{c, h}: M(c, h) & \rightarrow L(c, h), \\
\pi_{c, h}(u) & =u+J(c, h),
\end{aligned}
$$

and it satisfies $\operatorname{ker}\left(\pi_{c, h}\right)=J(c, h)$. Applying the functor gr, we obtain an epimorphism of modules over gr( $\mathrm{Vir}^{-}$)

$$
\operatorname{gr}\left(\pi_{c, h}\right): \operatorname{gr}(M(c, h)) \rightarrow \operatorname{gr}(L(c, h)),
$$

and this produces a natural isomorphism of modules over $\operatorname{gr}\left(\operatorname{Vir}^{-}\right)$

$$
\operatorname{gr}(M(c, h)) / K(c, h) \xrightarrow{\sim} \operatorname{gr}(L(c, h)),
$$

where

$$
K(c, h)=\operatorname{ker}\left(\operatorname{gr}\left(\pi_{c, h}\right)\right)
$$

Explicitly, we have

$$
\begin{equation*}
K(c, h)=\sum_{p \in \mathbb{N}} \gamma^{p}\left(J(c, h) \cap M(c, h)^{p}\right) . \tag{4.1}
\end{equation*}
$$

From these observations, we obtain the following four isomorphisms which are going to be used frequently implicitly.
Proposition 4.6. We pick a highest weight ( $c, h$ ). We have four (conformal) weight-preserving vector space isomorphisms:

$$
\begin{aligned}
M(c, h) & \xrightarrow{\sim} \operatorname{gr}(M(c, h)), \\
L_{\lambda}|c, h\rangle & \mapsto \gamma^{\operatorname{len}(\lambda)}\left(L_{\lambda}|c, h\rangle\right), \\
\operatorname{gr}(M(c, h)) & \xrightarrow{ } \mathbb{C}\left[L_{-1}, L_{-2}, \ldots\right], \\
\gamma^{\operatorname{len}(\lambda)}\left(L_{\lambda}|c, h\rangle\right) & \mapsto p_{\lambda}, \\
L(c, h) & \xrightarrow{\longrightarrow} \operatorname{gr}(L(c, h)), \\
L_{\lambda}(|c, h\rangle+J(c, h)) & \mapsto \gamma^{\operatorname{len}(\lambda)}\left(L_{\lambda}(|c, h\rangle+J(c, h))\right), \\
\operatorname{gr}(L(c, h)) & \xrightarrow{\rightarrow} \operatorname{gr}(M(c, h)) / K(c, h), \\
\gamma^{\operatorname{len}(\lambda)}\left(L_{\lambda}(|c, h\rangle+J(c, h))\right) & \mapsto \gamma^{\operatorname{len}(\lambda)}\left(L_{\lambda}|c, h\rangle\right)+K(c, h),
\end{aligned}
$$

where $\lambda$ is a partition.
In this article, we will deal with the polynomial algebra $\mathbb{C}\left[L_{-1}, L_{-2}, \ldots\right]$, its ideals and quotients. We will always use the degree reverse lexicographic order with $L_{-1}>L_{-2}>\ldots$. Actually, we can only use Gröbner basis theory with finitely generated polynomial algebras like $\mathbb{C}\left[L_{-1}, L_{-2}, \ldots, L_{-N}\right]$ for some $N \in \mathbb{N}$. But taking $N \rightarrow \infty$, we can obtain our desired results, see [Sal24] for details regarding this.

## 5. Fields over vector spaces

The vector space of formal distributions in $n \in \mathbb{N}$ variables, denoted by $\mathbb{C}\left[\left[x_{1}^{ \pm 1}, \ldots, x_{n}^{ \pm 1}\right]\right]$, is the set of functions $f: \mathbb{Z}^{n} \rightarrow \mathbb{C}$, written as $f\left(x_{1}, \ldots, x_{n}\right)=\sum_{m_{1}, \ldots, m_{n} \in \mathbb{Z}} f_{m_{1}, \ldots, m_{n}} x_{1}^{m_{1}} \ldots x_{n}^{m_{n}}$, with the natural operations of addition and multiplication by a scalar. The field of formal Laurent series, denoted by $\mathbb{C}((x))$, is the subspace of elements $f(x) \in \mathbb{C}\left[\left[x^{ \pm 1}\right]\right]$ such that there is $N \in \mathbb{Z}$ with $f_{n}=0$ for $n \leq N$. We also have $\mathbb{C}((x))=\operatorname{Frac}(\mathbb{C}[[x]])$, so $\mathbb{C}((x))$ is actually a field. If $V$ is a vector space, we similarly define $V\left[\left[x_{1}^{ \pm 1}, \ldots, x_{n}^{ \pm 1}\right]\right]$ and $V((x))$, but in this case, $V((x))$ is only a vector space.

Let $V$ be a vector space. The Fourier expansion of a formal distribution $a(z) \in V\left[\left[z^{ \pm 1}\right]\right]$, written as $a(z)=\sum_{n \in \mathbb{Z}} a_{n} z^{n}$, is conventionally written in the theory of vertex algebras as

$$
a(z)=\sum_{n \in \mathbb{Z}} a_{(n)} z^{-n-1},
$$

where

$$
a_{(n)}=a_{-n-1} .
$$

Let $V$ be a vector space, and let $a(z) \in \operatorname{End}(V)\left[\left[z^{ \pm 1}\right]\right]$ be a formal distribution. We set:

$$
\begin{aligned}
& a(z)_{+}=\sum_{n \leq-1} a_{(n)} z^{-n-1} \\
& a(z)_{-}=\sum_{n \geq 0} a_{(n)} z^{-n-1}
\end{aligned}
$$

A formal distribution $a(z)$ is a field if

$$
a(z) b=\sum_{n \in \mathbb{Z}} a_{(n)} b z^{-n-1} \in V((z)) \quad \text { for } b \in V .
$$

The vector space of fields over $V$ is denoted by $\mathcal{F}(V)$. We note that

$$
\mathcal{F}(V)=\operatorname{Hom}(V, V((z)))
$$

Therefore, we can define a field $a(z)$ by defining $a(z) b \in V((z))$ for $b \in V$.

Proposition 5.1 ([Noz08, Proposition 3.3.2]). Let $a(z), b(z) \in \mathcal{F}(V)$ be two fields. Then: $a(z) b(z): \in \operatorname{End}(V)\left[\left[z^{ \pm 1}\right]\right]$ is again a field, where $: a(z) b(z):$ is defined by

$$
: a(z) b(z): c=a(z)_{+} b(z) c+b(z) a(z)_{-} c \quad \text { for } c \in V
$$

We thus defined the notion of normal ordered product between fields $a(z), b(z) \in \mathcal{F}(V)$, denoted by : $a(z) b(z):$ : In general, the operation of normal ordered product is neither commutative nor associative. We follow the convention that the normal ordered product is read from right to left, so that, by definition,

$$
: a(z) b(z) c(z):=: a(z)(: b(z) c(z):): .
$$

Lemma 5.2 ([Noz08, Proposition 3.3.3]). Let $a(z), b(z) \in \mathcal{F}(V)$ be two fields. Their normal ordered product is written explicitly as

$$
: a(z) b(z):=\sum_{j \in \mathbb{Z}}: a(z) b(z):(j) z^{-j-1}
$$

with

$$
: a(z) b(z):{ }_{(j)} c=\sum_{n \leq-1} a_{(n)} b_{(j-n-1)} c+\sum_{n \geq 0} b_{(j-n-1)} a_{(n)} c \quad \text { for } c \in V .
$$

Lemma 5.3. Let $V$ be a vector space. We consider $s$ fields $a^{1}(z), \ldots, a^{s}(z) \in \mathcal{F}(V)$, with $s \geq 2$, and let $b \in V$. For $l \in \mathbb{Z}$,

$$
: a^{1}(z) a^{2}(z) \ldots a^{s}(z):_{(l)} b=\sum_{n_{1}, \ldots, n_{s-1} \in \mathbb{N}} \sum_{k=0}^{s-1} R_{n_{1}, \ldots, n_{s-1}}^{l, k}\left(a^{1}(z), \ldots, a^{s}(z)\right) b
$$

where $R_{n_{1}, \ldots, n_{s-1}}^{l, k}\left(a^{1}(z), \ldots, a^{s}(z)\right)$ is the sum of $\binom{s-1}{k}$ terms given by

$$
\begin{aligned}
& R_{n_{1}, \ldots, n_{s-1}}^{l, k}\left(a^{1}(z), \ldots, a^{s}(z)\right)= \\
& \quad \sum_{\substack{1 \leq i_{1}<\cdots<i_{k} \leq s-1 \\
1 \leq j_{1}<\cdots<j_{s-1-k} \leq s-1}}^{\left\{i_{1}, \ldots, i_{k}\right\} \cup\left\{j_{1}, \ldots, j_{s-1}-k\right\}=\{1, \ldots, s-1\}}
\end{aligned} a_{\left(-n_{\left.j_{1}-1\right)}^{j_{1}} \ldots a_{\left(-n_{j_{s-1-k}-1}\right)}^{j_{s-1-k}} a_{\left(l-k-\sum_{r=1}^{s} n_{i_{r}}+\sum_{r=1}^{s-1-k} n_{\left.j_{r}\right)}\right)} a_{\left(n_{i_{k}}\right)}^{i_{k}} \ldots a_{\left(n_{i_{1}}\right)}^{i_{1}} .\right.}
$$

Proof. This follows from Lemma 5.2 and induction on $s$.

## 6. Modules over the simple Virasoro vertex algebras

Let $c \in \mathbb{C}$. We make the subalgebra $\operatorname{Vir}^{\geq} \oplus \mathbb{C} L_{-1}$ of Vir act on $\mathbb{C}$ as follows:

$$
L_{n} 1=0 \text { for } n \geq-1 \text { and } C 1=c .
$$

The induced Vir-module

$$
\operatorname{Vir}^{c}=\operatorname{Ind}_{\mathrm{Vir} \geq \oplus \mathbb{C} L_{-1}}^{\mathrm{Vir}}=U(\mathrm{Vir}) \otimes_{U\left(\mathrm{Vir} \geq \oplus \mathbb{C} L_{-1}\right)} \mathbb{C}
$$

carries the structure of a vertex algebra and is called the universal Virasoro vertex algebra of central charge $c$, see [FBZ01, §2] or [Kac17, §2] for details.

The vertex algebra $\operatorname{Vir}^{c}$ has a unique maximal proper ideal. We denote by $\operatorname{Vir}_{c}$ the unique simple quotient, and we call it the simple Virasoro vertex algebra of central charge c. Let $p, q \geq 2$ be relatively prime integers, and we set

$$
c_{p, q}=1-\frac{6(p-q)^{2}}{p q} .
$$

Let $V$ be a Vir-module. A vector $u$ in $V$ is called singular if it is nonzero and

$$
L_{n} u=0 \quad \text { for } n \in \mathbb{Z}_{+} .
$$

Theorem 6.1 ([GK07]). The following are equivalent:
(i) $\operatorname{Vir}^{c}$ is not simple, i.e., $\operatorname{Vir}^{c} \neq \operatorname{Vir}_{c}$;
(ii) $c$ is of the form $c_{p, q}$ for some $p, q \geq 2$ relatively prime integers.

Moreover, the maximal proper ideal of $\operatorname{Vir}^{c_{p, q}}$ is generated by a singular vector of conformal weight $(p-1)(q-1)$, denoted by $a_{p, q}$. In the expression

$$
a_{p, q}=\sum_{\substack{\lambda \vdash(p-1)(q-1) \\ \lambda_{\operatorname{len}}(\lambda) \geq 2}} c_{\lambda} L_{\lambda}|0\rangle,
$$

where $c_{\lambda} \in \mathbb{Q}$, the coefficient of $L_{-2}^{(p-1)(q-1) / 2}$ is nonzero.
Proposition 6.2. Let $V$ be a vertex algebra, and let $Y^{M}: V \rightarrow \mathcal{F}(M)$ be a $V$-module. For $s, n_{1}, \ldots, n_{s} \in \mathbb{N}$ and $a^{1}, \ldots, a^{s} \in V$,

$$
Y^{M}\left(a_{\left(-n_{1}-1\right)}^{1} \ldots a_{\left(-n_{s}-1\right)}^{s}|0\rangle, z\right)=\frac{: \partial_{z}^{n_{1}} Y^{M}\left(a^{1}, z\right) \ldots \partial_{z}^{n_{s}} Y^{M}\left(a^{s}, z\right):}{n_{1}!\ldots n_{s}!} .
$$

Proof. This is a consequence of the $n$-product identity for modules over vertex algebras (LL04, (5.2.16)]).

We are interested in the irreducible modules over the simple Virasoro vertex algebras Vir ${ }_{p, q}=$ $\operatorname{Vir}_{c_{p, q}}=L\left(c_{p, q}, 0\right)$, where $p, q \geq 2$ are relatively prime integers. In this context, the following constants play a crucial role. For integers $m, n$ such that $0<m<p$ and $0<n<q$, we set

$$
h_{m, n}=\frac{(n p-m q)^{2}-(p-q)^{2}}{4 p q} .
$$

Theorem 6.3 (Wan93). We set $c=c_{p, q}$ for some $p, q \geq 2$ relatively prime integers. Then the irreducible modules over $\operatorname{Vir}_{c}$ are $L\left(c, h_{m, n}\right)$ for integers $m, n$ such that $0<m<p$ and $0<n<q$. Let $Y_{\mathrm{Vir}^{c}}^{L\left(c, h_{m, n}\right)}: \operatorname{Vir}^{c} \rightarrow \mathcal{F}\left(L\left(c, h_{m, n}\right)\right)$ be the state-field correspondence of $L\left(c, h_{m, n}\right)$ as a module over $\operatorname{Vir}^{c}$, and let $Y_{\operatorname{Vir}_{c}}^{L\left(c, h_{m, n}\right)}$ : $\operatorname{Vir}_{c} \rightarrow \mathcal{F}\left(L\left(c, h_{m, n}\right)\right)$ be the state-field correspondence of $L\left(c, h_{m, n}\right)$ as a module over $\operatorname{Vir}_{c}$. Then $Y_{\operatorname{Vir}^{c}}^{L\left(c, h_{m, n}\right)}$ factors through $Y_{\operatorname{Vir}_{c}}^{L\left(c, h_{m, n}\right)}$, i.e., the following diagram commutes

where the horizontal arrow is the quotient map.
We are also interested in the refined character of these irreducible modules. The ordinary character is fortunately already known.

Theorem 6.4 (FF84). Let $p, q \geq 2$ be relatively prime integers, and let $m, n$ be integers such that $0<m<p$ and $0<n<q$. Then

$$
\begin{aligned}
\operatorname{ch}_{L\left(c_{p, q}, h_{m, n}\right)}(q) & =\frac{1}{(q)_{\infty}} \sum_{k \in \mathbb{Z}} q^{\frac{(2 k p q+m q-n p)^{2}-(p-q)^{2}}{4 p q}}-q^{\frac{(2 k p q+m q+n p)^{2}-(p-q)^{2}}{4 p q}} \\
& =\frac{q^{h_{m, n}}}{(q)_{\infty}} \sum_{k \in \mathbb{Z}} q^{k^{2} p q+k(m q-n p)}-q^{k^{2} p q+k(m q+n p)+m n} .
\end{aligned}
$$

In this article, we consider:

$$
\begin{aligned}
& p=2 \\
& q=2 s+1 \quad \text { for } s \in \mathbb{Z}_{+} .
\end{aligned}
$$

By Theorem 6.3. $\operatorname{Vir}_{2,2 s+1}$ has $s$ irreducible modules $L\left(c_{2,2 s+1}, h_{1,1}\right), \ldots, L\left(c_{2,2 s+1}, h_{1, s}\right)$, known collectively as the boundary minimal models.

## 7. The Li filtration

Let $V$ be a vertex algebra, and let $\left(a^{i}\right)_{i \in I}$ be a family of strong generators of $V$. For $p \in \mathbb{Z}$, we set

$$
F_{p} V=\operatorname{span}\left\{a_{\left(-n_{1}-1\right)}^{i_{1}} \ldots a_{\left(-n_{s}-1\right)}^{i_{s}}|0\rangle \mid s, n_{1}, \ldots, n_{s} \in \mathbb{N}, i_{1}, \ldots, i_{s} \in I, n_{1}+\cdots+n_{s} \geq p\right\} .
$$

Proposition 7.1 ([Li05]). The filtration $\left(F_{p} V\right)_{p \in \mathbb{Z}}$ satisfies:
(i) $F_{p} V=V$ for $p \leq 0$;
(ii) $|0\rangle \in F_{0} V \supseteq F_{1} V \supseteq \ldots$;
(iii) $T\left(F_{p} V\right) \subseteq F_{p+1} V$ for $p \in \mathbb{Z}$;
(iv) $a_{(n)} F_{q} V \subseteq F_{p+q-n-1} V$ for $p, q \in \mathbb{Z}, a \in F_{p} V$ and $n \in \mathbb{Z}$;
(v) $a_{(n)} F_{q} V \subseteq F_{p+q-n} V$ for $p, q \in \mathbb{Z}, a \in F_{p} V$ and $n \in \mathbb{N}$.

Let

$$
\operatorname{gr}_{F}(V)=\bigoplus_{p \in \mathbb{N}} F_{p} V / F_{p+1} V
$$

be the associated graded vector space. By [Li05], the vector space $\operatorname{gr}_{F}(V)$ is a vertex Poisson algebra with operations given as follows. For $p, q \in \mathbb{N}, a \in F_{p} V$ and $b \in F_{q} V$, we set:

$$
\begin{aligned}
\sigma_{p}(a) \sigma_{q}(b) & =\sigma_{p+q}\left(a_{(-1)} b\right), \\
T\left(\sigma_{p}(a)\right) & =\sigma_{p+1}(T a), \\
Y_{-}\left(\sigma_{p}(a), z\right) \sigma_{q}(b) & =\sum_{n \in \mathbb{N}} \sigma_{p+q-n}\left(a_{(n)} b\right) z^{-n-1},
\end{aligned}
$$

where $\sigma_{p}: F_{p} V \rightarrow \operatorname{gr}_{F}(V)$ is the principal symbol map, which is the composition of the natural maps $F_{p} V \rightarrow F_{p} V / F_{p+1} V$ and $F_{p} V / F_{p+1} V \hookrightarrow \operatorname{gr}_{F}(V)$. The unit is $\sigma^{0}(|0\rangle)$. The filtration $\left(F_{p} V\right)_{p \in \mathbb{Z}}$ is called the Li filtration of $V$.

Lemma 7.2 ([Li05, Lemma 2.9]). Let $V$ be a vertex algebra. Then

$$
F_{p} V=\operatorname{span}\left\{a_{(-i-1)} b \mid a \in V, i \in \mathbb{Z}_{+}, b \in F_{p-i} V\right\} \quad \text { for } p \in \mathbb{Z}_{+} .
$$

By Lemma 7.2, the Li filtration depends only on $V$ and not on the choice of the strong generators. If $V$ is graded with Hamiltonian $H$, then $H\left(F_{p} V\right) \subseteq F_{p} V$ for $p \in \mathbb{Z}$. Therefore, we can define an operator $H \in \operatorname{End}\left(\operatorname{gr}_{F}(V)\right)$ as $H\left(\sigma_{p}(a)\right)=\sigma_{p}(H a)$ for $p \in \mathbb{N}$ and $a \in F_{p} V$. For $p \in \mathbb{Z}$ and $\Delta \in \mathbb{C}$, we define $F_{p} V_{\Delta}=F_{p} V \cap V_{\Delta}$. Since $H\left(F_{p} V\right) \subseteq F_{p} V$ for $p \in \mathbb{Z}$, we have

$$
F_{p} V=\bigoplus_{\Delta \in \mathbb{C}} F_{p} V_{\Delta} \quad \text { for } p \in \mathbb{Z}
$$

For $\Delta \in \mathbb{C}$, we define $\operatorname{gr}_{F}(V)_{\Delta}=\bigoplus_{p \in \mathbb{N}} \sigma_{p}\left(F_{p} V_{\Delta}\right)$. Then $H a=\Delta a$ for $a \in \operatorname{gr}_{F}(V)_{\Delta}$. The family of subspaces $\left(\operatorname{gr}_{F}(V)_{\Delta}\right)_{\Delta \in \mathbb{C}}$ satisfies $\operatorname{gr}_{F}(V)=\bigoplus_{\Delta \in \mathbb{C}} \operatorname{gr}_{F}(V)_{\Delta}$. Therefore, the operator $H \in \operatorname{End}\left(\operatorname{gr}_{F}(V)\right)$ is diagonalizable with $\operatorname{gr}_{F}(V)_{\Delta}=\operatorname{ker}\left(H-\Delta \operatorname{Id}_{\operatorname{gr}_{F}(V)}\right)$. In fact, it is possible to prove that this diagonalizable operator $H$ is actually a Hamiltonian of $\operatorname{gr}_{F}(V)$.

We have the natural vector space isomorphisms

$$
\sigma_{p}\left(F_{p} V_{\Delta}\right) \cong F_{p} V_{\Delta} / F_{p+1} V_{\Delta} \quad \text { for } p \in \mathbb{Z} \text { and } \Delta \in \mathbb{C}
$$

and the refined grading

$$
\begin{equation*}
\operatorname{gr}_{F}(V)=\bigoplus_{\substack{p \in \mathbb{N} \\ \Delta \in \mathbb{C}}} \sigma_{p}\left(F_{p} V_{\Delta}\right) \tag{7.1}
\end{equation*}
$$

By (7.1), when $\operatorname{dim}\left(V_{\Delta}\right)<\infty$ for $\Delta \in \mathbb{C}$, it is natural to define the refined character of $V$ with respect to the Li filtration as

$$
\operatorname{ch}_{\operatorname{gr}_{F}(V)}(t, q)=\sum_{\substack{p \in \mathbb{N} \\ \Delta \in \mathbb{C}}} \operatorname{dim}\left(\sigma_{p}\left(F_{p} V_{\Delta}\right)\right) t^{p} q^{\Delta}
$$

If $f: V_{1} \rightarrow V_{2}$ is a homomorphism of vertex algebras, then

$$
\begin{aligned}
\operatorname{gr}_{F}(f): \operatorname{gr}_{F}\left(V_{1}\right) & \rightarrow \operatorname{gr}_{F}\left(V_{2}\right), \\
\operatorname{gr}_{F}(f)\left(\sigma_{p}^{V_{1}}(a)\right) & =\sigma_{p}^{V_{2}}(f(a)) \quad \text { for } p \in \mathbb{N} \text { and } a \in F_{p} V_{1}
\end{aligned}
$$

defines a homomorphism of vertex Poisson algebras. If $V_{1}$ and $V_{2}$ are graded, then we require that $f$ respects the gradings of $V_{1}$ and $V_{2}$, and this implies that $\operatorname{gr}_{F}(f)$ also respects the gradings of $\operatorname{gr}_{F}\left(V_{1}\right)$ and $\operatorname{gr}_{F}\left(V_{2}\right)$. Therefore, we obtain a functor

$$
\operatorname{gr}_{F}:\{(\text { graded }) \text { vertex algebras }\} \rightarrow\{(\text { graded }) \text { vertex Poisson algebras }\} .
$$

Example $7.3\left(\operatorname{gr}_{F}\left(\mathrm{Vir}^{c}\right)\right)$. We pick $c \in \mathbb{C}$. We have an isomorphism

$$
\begin{aligned}
\operatorname{gr}_{F}\left(\mathrm{Vir}^{c}\right) & \xrightarrow{\sim} \mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right], \\
\sigma_{\Delta(\lambda)-\operatorname{clen}(\lambda)}\left(L_{\lambda}|0\rangle\right) & \mapsto p_{\lambda} \text { for } \lambda \text { a composition without ones. }
\end{aligned}
$$

The derivation $T \in \operatorname{Der}\left(\mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right]\right)$ is given by $T\left(L_{-n}\right)=(n-1) L_{-n-1}$ for $n \geq 2$, which is extended to a derivation. The Poisson structure of $\mathrm{gr}^{G}\left(\mathrm{Vir}^{c}\right)$ is trivial (i.e., the map $Y_{-}$is zero). The refined character is given explicitly by

$$
\operatorname{ch}_{\operatorname{gr}_{F}\left(\operatorname{Vir}^{c}\right)}(t, q)=\frac{1}{\prod_{k \geq 2}\left(1-t^{k-2} q^{k}\right)}
$$

Let $V$ be a vertex algebra, let $\left(a^{i}\right)_{i \in I}$ be a family of strong generators of $V$, and let $M$ be a $V$-module. For $p \in \mathbb{Z}$, we set

$$
F_{p} M=\operatorname{span}\left\{a_{\left(-n_{1}-1\right)}^{i_{1} M} \ldots a_{\left(-n_{s}-1\right)}^{i_{s} M} u \mid s, n_{1}, \ldots, n_{s} \in \mathbb{N}, i_{1}, \ldots, i_{s} \in I, u \in M, n_{1}+\cdots+n_{s} \geq p\right\}
$$

Proposition 7.4 (Li05]). The filtration $\left(F_{p} M\right)_{p \in \mathbb{Z}}$ satisfies:
(i) $M=F_{p} M$ for $p \leq 0$;
(ii) $F_{0} M \supseteq F_{1} M \supseteq \ldots$;
(iii) $a_{(n)} F_{q} M \subseteq F_{p+q-n-1} M$ for $p, q \in \mathbb{Z}, a \in F_{p} V$ and $n \in \mathbb{Z}$;
(iv) $a_{(n)} F_{q} M \subseteq F_{p+q-n} M$ for $p, q \in \mathbb{Z}, a \in F_{p} V$ and $n \in \mathbb{N}$.

Let

$$
\operatorname{gr}_{F}(M)=\bigoplus_{p \in \mathbb{N}} F_{p} M / F_{p+1} M
$$

be the associated graded vector space. By [i05], the vector space $\operatorname{gr}_{F}(M)$ is a module over $\operatorname{gr}_{F}(V)$ with operations given as follows. For $p, q \in \mathbb{N}, a \in F_{p} V$ and $u \in F_{q} M$, we set:

$$
\begin{aligned}
\sigma_{p}(a) \sigma_{q}^{M}(u) & =\sigma_{p+q}^{M}\left(a_{(-1)}^{M} u\right) \\
Y_{-}^{M}\left(\sigma_{p}(a), z\right) \sigma_{q}^{M}(u) & =\sum_{n \in \mathbb{N}} \sigma_{p+q-n}^{M}\left(a_{(n)}^{M} u\right) z^{-n-1}
\end{aligned}
$$

where $\sigma_{p}^{M}: F_{p} M \rightarrow \operatorname{gr}_{F}(M)$ is the principal symbol map. The filtration $\left(F_{p} M\right)_{p \in \mathbb{Z}}$ is called the Li filtration of $M$.
Lemma 7.5 ( [Li05, Lemma 2.9]). Let $V$ be a vertex algebra, and let $M$ be a $V$-module. Then

$$
F_{p} M=\operatorname{span}\left\{a_{(-i-1)}^{M} u \mid a \in V, i \in \mathbb{Z}_{+}, u \in F_{p-i} M\right\} \quad \text { for } p \in \mathbb{Z}_{+} .
$$

By Lemma 7.5, the Li filtration depends only on $M$ and not on the choice of the strong generators of $V$. If $V$ is graded with Hamiltonian $H$, and $M$ is graded with Hamiltonian $H^{M}$, then $H^{M}\left(F_{p} M\right) \subseteq F_{p} M$ for $p \in \mathbb{Z}$. Therefore, we can define an operator $H^{M} \in \operatorname{End}\left(\operatorname{gr}_{F}(M)\right)$ as $H^{M}\left(\sigma_{p}^{M}(u)\right)=\sigma_{p}^{M}\left(H^{M} u\right)$ for $p \in \mathbb{N}$ and $u \in F_{p} M$. For $p \in \mathbb{Z}$ and $\Delta \in \mathbb{C}$, we define $F_{p} M_{\Delta}=F_{p} M \cap M_{\Delta}$. Since $H^{M}\left(F_{p} M\right) \subseteq F_{p} M$ for $p \in \mathbb{Z}$, we have

$$
F_{p} M=\bigoplus_{\Delta \in \mathbb{C}} F_{p} M_{\Delta} \quad \text { for } p \in \mathbb{Z}
$$

For $\Delta \in \mathbb{C}$, we define $\operatorname{gr}_{F}(M)_{\Delta}=\bigoplus_{p \in \mathbb{N}} \sigma_{p}^{M}\left(F_{p} M_{\Delta}\right)$. Then $H^{M} u=\Delta u$ for $u \in \operatorname{gr}_{F}(M)_{\Delta}$. The family of subspaces $\left(\operatorname{gr}_{F}(M)_{\Delta}\right)_{\Delta \in \mathbb{C}}$ satisfies $\operatorname{gr}_{F}(M)=\bigoplus_{\Delta \in \mathbb{C}} \operatorname{gr}_{F}(M)_{\Delta}$. Therefore, the operator $H^{M} \in \operatorname{End}\left(\operatorname{gr}_{F}(M)\right)$ is diagonalizable with $\operatorname{gr}_{F}(M)_{\Delta}=\operatorname{ker}\left(H^{M}-\Delta \operatorname{Id}_{\operatorname{gr}_{F}(M)}\right)$. In fact, it is possible to prove that this diagonalizable operator $H^{M}$ is actually a Hamiltonian of $\mathrm{gr}_{F}(M)$.

We have the natural vector space isomorphisms

$$
\sigma_{p}^{M}\left(F_{p} M_{\Delta}\right) \cong F_{p} M_{\Delta} / F_{p+1} M_{\Delta} \quad \text { for } p \in \mathbb{Z} \text { and } \Delta \in \mathbb{C}
$$

and the refined grading

$$
\begin{equation*}
\operatorname{gr}_{F}(M)=\bigoplus_{\substack{p \in \mathbb{N} \\ \Delta \in \mathbb{C}}} \sigma_{p}\left(F_{p} M_{\Delta}\right) \tag{7.2}
\end{equation*}
$$

By (7.2), when $\operatorname{dim}(M)_{\Delta}<\infty$ for $\Delta \in \mathbb{C}$, it is natural to define the refined character of $M$ with respect to the Li filtration as

$$
\operatorname{ch}_{\operatorname{gr}_{F}(M)}(t, q)=\sum_{\substack{p \in \mathbb{N} \\ \Delta \in \mathbb{C}}} \operatorname{dim}\left(\sigma_{p}\left(F_{p} M_{\Delta}\right)\right) t^{p} q^{\Delta}
$$

If $f: M_{1} \rightarrow M_{2}$ is a homomorphism of $V$-modules, then

$$
\begin{aligned}
\operatorname{gr}_{F}(f): \operatorname{gr}_{F}\left(M_{1}\right) & \rightarrow \operatorname{gr}_{F}\left(M_{2}\right), \\
\operatorname{gr}_{F}(f)\left(\sigma_{p}^{M_{1}}(u)\right) & =\sigma_{p}^{M_{2}}(f(u)) \quad \text { for } p \in \mathbb{N} \text { and } u \in F_{p} M_{1}
\end{aligned}
$$

defines a homomorphism of $\operatorname{gr}_{F}(V)$-modules. If $M_{1}$ and $M_{2}$ are graded, then we require that $f$ respects the gradings of $M_{1}$ and $M_{2}$, and this implies that $\operatorname{gr}_{F}(f)$ also respects the gradings of $\operatorname{gr}_{F}\left(M_{1}\right)$ and $\operatorname{gr}_{F}\left(M_{2}\right)$. Therefore, we obtain a functor

$$
\left.\operatorname{gr}_{F}:\{\text { (graded }) V \text {-modules }\right\} \rightarrow\left\{(\text { graded }) \operatorname{gr}_{F}(V) \text {-modules }\right\} .
$$

Example $7.6\left(\operatorname{gr}_{F}(M(c, h))\right)$. We pick a highest weight $(c, h)$. From Example 7.3, $\mathrm{gr}_{F}\left(\mathrm{Vir}^{c}\right)$ is isomorphic to $\mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right]$. We have an isomorphism

$$
\begin{aligned}
\operatorname{gr}_{F}(M(c, h)) & \xrightarrow{\sim} \bigoplus_{k \in \mathbb{N}} \mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right] L_{-1}^{k}, \\
\sigma_{\Delta(\lambda)-\operatorname{clen}(\lambda)}\left(L_{\lambda}|c, h\rangle\right) & \mapsto u_{\lambda} \quad \text { for } \lambda \text { a composition. }
\end{aligned}
$$

The refined character is given explicitly by

$$
\operatorname{ch}_{\operatorname{gr}_{F}(M(c, h))}(t, q)=\frac{q^{h}}{(1-q) \prod_{k \geq 2}\left(1-t^{k-2} q^{k}\right)} .
$$

## 8. Classically free vertex algebras and their modules

Let $V$ be a vertex algebra. By Lemma 7.2, we have

$$
C_{2} V=\operatorname{span}\left\{a_{(-2)} b \mid a, b \in V\right\}=F_{1} V .
$$

We define the Zhu $C_{2}$-algebra of $V$ by

$$
R_{V}=V / C_{2} V=F_{0} V / F_{1} V \subseteq \operatorname{gr}_{F}(V)
$$

In Zhu's original article Zhu96 and other works, $R_{V}$ is denoted by $A(V)$.
The fact that $\operatorname{gr}_{F}(V)$ is a vertex Poisson algebra implies that $R_{V}$ is a Poisson algebra with operations given as follows. For $a, b \in V$, we set:

$$
\begin{aligned}
\sigma_{0}(a) \sigma_{0}(b) & =\sigma_{0}\left(a_{(-1)} b\right), \\
\left\{\sigma_{0}(a), \sigma_{0}(b)\right\} & =\sigma_{0}\left(a_{(0)} b\right) .
\end{aligned}
$$

If $V$ is graded, then, as we explained in $\S 7, \mathrm{gr}_{F}(V)$ is graded. Thus, $R_{V}$ is also graded.
We have constructed a functor

$$
R:\{\text { (graded) vertex algebras }\} \rightarrow\{\text { (graded) Poisson algebras }\} .
$$

Oftentimes, some condition on $R_{V}$ implies or is equivalent to some condition on $V$. The vertex algebra $V$ is called $C_{2}$-cofinite if $R_{V}$ is finite dimensional.

Example 8.1 ( $R_{\text {Vir }^{c}}$ and $R_{\text {Vir }_{c}}$ ). We pick $c \in \mathbb{C}$. We consider $\mathbb{C}\left[L_{-2}\right]$ as the polynomial algebra in one variable $L_{-2}$, and we equip it with the trivial Poisson bracket. By Example 7.3, we have the following isomorphism of Poisson algebras

$$
\begin{aligned}
R_{\mathrm{Vir}^{c}} & \xrightarrow{\sim} \mathbb{C}\left[L_{-2}\right], \\
\sigma_{0}\left(L_{-2}|0\rangle\right) & \mapsto L_{-2} .
\end{aligned}
$$

We now move onto $\operatorname{Vir}_{c}$. If $c$ is not of the form $c_{p, q}$ for some $p, q \geq 2$ relatively prime integers, then $\operatorname{Vir}_{c}=\operatorname{Vir}^{c}$ by Theorem 6.1, and we have already solved the problem. Therefore, we assume $c$ is of this form.

We have a natural quotient map

$$
\begin{aligned}
\pi_{c}: \operatorname{Vir}^{c} & \rightarrow \operatorname{Vir}_{c} \\
\pi_{c}(a) & =a+U(\operatorname{Vir})\left\{a_{p, q}\right\} .
\end{aligned}
$$

Applying the functor $R$, we obtain an epimorphism

$$
R_{\pi_{c}}: R_{\mathrm{Vir}^{c}} \rightarrow R_{\mathrm{Vir}_{c}} .
$$

From the equation $\operatorname{ker}\left(R_{\pi_{c}}\right)=\sigma_{0}\left(U(\operatorname{Vir})\left\{a_{p, q}\right\}\right)$ and Theorem 6.1, we obtain

$$
\operatorname{ker}\left(R_{\pi_{c}}\right)=\left(\sigma_{0}\left(L_{-2}^{(p-1)(q-1) / 2}|0\rangle\right)\right) .
$$

In summary,

$$
R_{\operatorname{Vir}_{p, q}} \cong \mathbb{C}\left[L_{-2}\right] /\left(L_{-2}^{(p-1)(q-1) / 2}\right)
$$

Thus, $\operatorname{Vir}^{c}$ is never $C_{2}$-cofinite, while $\operatorname{Vir}_{c}$ is $C_{2}$-cofinite only when $c$ is of the form $c_{p, q}$ for some $p, q \geq 2$ relatively prime integers.

Lemma 8.2 ( $[\underline{\operatorname{Li} 05}, ~ C o r o l l a r y ~ 4.3]) . ~ L e t ~ V e ~ a ~ v e r t e x ~ a l g e b r a . ~ A s ~ a ~ d i f f e r e n t i a l ~ a l g e b r a, ~ g r ~ F r ~(V) ~$ is generated by $R_{V}$, i.e.,

$$
\operatorname{gr}_{F}(V)=\left(R_{V}\right)_{T} .
$$

Let $V$ be a (graded) vertex algebra. We have a natural (graded) algebra inclusion inc : $R_{V} \hookrightarrow \operatorname{gr}_{F}(V)$. By the universal property of inc : $R_{V} \hookrightarrow J R_{V}$ (see Appendix B), there is a (graded) differential algebra homomorphism $\phi_{V}: J R_{V} \rightarrow \operatorname{gr}_{F}(V)$ such that the following diagram commutes


Because $R_{V}$ is a (graded) Poisson algebra, we can equip $J R_{V}$ with the level 0 vertex Poisson algebra structure, as explained in Appendix C. From now on, $J R_{V}$ will be considered as a (graded) vertex Poisson algebra.

Lemma 8.3. Let $V$ be a (graded) vertex algebra. The (graded) differential algebra homomorphism $\phi_{V}: J R_{V} \rightarrow \operatorname{gr}_{F}(V)$ defined above is surjective and is actually a (graded) vertex Poisson algebra homomorphism.

Proof. The homomorphism $\phi_{V}$ is surjective by Lemma 8.2. The fact that $\phi_{V}$ is a (graded) vertex Poisson algebra homomorphism is explained in Ara12, Proposition 2.5.1].

When $\phi_{V}$ is an isomorphism, we say $V$ is classically free.

Example $8.4\left(J R_{\mathrm{Vir}^{c}}\right.$ and $\left.J R_{\mathrm{Vir}_{c}}\right)$. Let $c \in \mathbb{C}$. Then $\mathrm{Vir}^{c}$ is classically free because

$$
\operatorname{gr}_{F}\left(\operatorname{Vir}^{c}\right) \cong \mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right]
$$

by Example 7.3 and

$$
J R_{\mathrm{Vir}^{c}} \cong J\left(C\left[L_{-2}\right]\right)=\mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right]
$$

by Example 8.1 and Appendix B.
We now move onto $\operatorname{Vir}_{c}$. If $c$ is not of the form $c_{p, q}$ for some $p, q \geq 2$ relatively prime integers, then $\operatorname{Vir}_{c}=\operatorname{Vir}^{c}$ by Theorem 6.1, and we have already solved the problem. Therefore, we assume $c$ is of this form. Then

$$
J R_{\mathrm{Vir}_{p, q}} \cong J\left(\mathbb{C}\left[L_{-2}\right] /\left(L_{-2}^{(p-1)(q-1) / 2}\right)\right)=\mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right] /\left(L_{-2}^{(p-1)(q-1) / 2}\right)_{\partial}
$$

by Example 8.1 and Appendix B.
Example 8.5. If $q>p \geq 2$ are relatively prime integers, then $\operatorname{Vir}_{p, q}$ is classically free if and only if $p=2$ by [VEH21].
Example 8.6. It was proven in AVEH22] that the Ising model Vir ${ }_{3,4}$ is not classically free. In fact, by [AVEH22, Theorem 2],

$$
\operatorname{ker}\left(\phi_{\operatorname{Vir}_{3,4}}\right)=(b)_{\partial},
$$

where

$$
b=L_{-4} L_{-3} L_{-2}+\frac{1}{6} L_{-5} L_{-2}^{2},
$$

and $(b)_{\partial}$ is the differential ideal generated by $b$, cf. Appendix B and Example 7.3 where $\partial$ is denoted by $T$.

Let $V$ be a vertex algebra, and let $M$ be a module over $V$. By Lemma 7.5, we have

$$
C_{2} M=\operatorname{span}\left\{a_{(-2)}^{M} u \mid a \in V, u \in M\right\}=F_{1} M
$$

We define the $Z h u C_{2}$-module of $M$ by

$$
R_{M}=M / C_{2} M=F_{0} M / F_{1} M \subseteq \operatorname{gr}_{F}(M)
$$

The fact that $\operatorname{gr}_{F}(M)$ is a module over $\operatorname{gr}_{F}(V)$ implies that $R_{M}$ is a module over $R_{V}$ with operations given as follows. For $a \in V$ and $u \in M$, we set:

$$
\begin{aligned}
\sigma_{0}(a) \sigma_{0}^{M}(u) & =\sigma_{0}^{M}\left(a_{(-1)}^{M} u\right), \\
\left\{\sigma_{0}(a), \sigma_{0}^{M}(u)\right\} & =\sigma_{0}^{M}\left(a_{(0)}^{M} u\right) .
\end{aligned}
$$

If $V$ is graded and $M$ is a graded $V$-module, then, as we explained in $\$ 7, \operatorname{gr}_{F}(M)$ is a graded $\operatorname{gr}_{F}(V)$-module. Thus, $R_{M}$ is also a graded $R_{V}$-module.

We have constructed a functor

$$
R:\{\text { (graded) } V \text {-modules }\} \rightarrow\left\{\text { (graded) } R_{V^{V}} \text {-modules }\right\}
$$

Example $8.7\left(R_{M(c, h)}\right.$ and $\left.R_{L(c, h)}\right)$. We pick a highest weight $(c, h)$. As in Example 8.1, we consider $\mathbb{C}\left[L_{-2}\right]$ as the polynomial algebra in one variable $L_{-2}$, and we equip it with the trivial Poisson bracket. We consider $\bigoplus_{k \in \mathbb{N}} \mathbb{C}\left[L_{-2}\right] L_{-1}^{k} \cong \mathbb{C}\left[L_{-2}, L_{-1}\right]$ as a module over the Poisson algebra $\mathbb{C}\left[L_{-2}\right]$ with Poisson bracket given by $\left\{L_{-2}, L_{-1}^{k}\right\}=L_{-1}^{k+1}$ for $k \in \mathbb{N}$. By Example 7.6 and Example 8.1, we have the following isomorphism of modules over Poisson algebras

$$
\begin{aligned}
R_{M(c, h)} & \stackrel{\sim}{\rightarrow} \bigoplus_{k \in \mathbb{N}} \mathbb{C}\left[L_{-2}\right] L_{-1}^{k}, \\
\sigma_{0}\left(L_{-2}|c, h\rangle\right) & \mapsto L_{-2} \\
\sigma_{0}\left(L_{-1}|c, h\rangle\right) & \mapsto L_{-1} .
\end{aligned}
$$

As in Example 8.1, we obtain

$$
R_{L(c, h)} \cong \frac{\bigoplus_{k \in \mathbb{N}} \mathbb{C}\left[L_{-2}\right] L_{-1}^{k}}{\sigma_{0}(J(c, h))}
$$

Theorem 8.8 ([Li05, Lemma 4.2]). Let $V$ be a vertex algebra, and let $M$ be a $V$-module. As a $\operatorname{gr}_{F}(V)$-module without the Poisson structure, $\operatorname{gr}_{F}(M)$ is generated by $R_{M}$, i.e.,

$$
\operatorname{gr}_{F}(M)=\operatorname{gr}_{F}(V) R_{M} .
$$

Let $V$ be a (graded) vertex algebra, and let $M$ be a (graded) $V$-module. We have a natural (graded) inclusion inc : $R_{M} \hookrightarrow \operatorname{gr}_{F}(M)$ of (graded) $R_{V}$-modules. As we explained in Appendix C, we can consider $J R_{V} \otimes_{R_{V}} R_{M}$ as a (graded) $J R_{V}$-module. Because we have a (graded) epimorphism of vertex Poisson algebras $\phi_{V}: J R_{V} \rightarrow \operatorname{gr}_{F}(V)$, we can consider the (graded) $\operatorname{gr}_{F}(V)$-module $\operatorname{gr}_{F}(M)$ as a (graded) $J R_{V}$-module. By the universal property of inc : $R_{M} \hookrightarrow J R_{V} \otimes_{R_{V}} R_{M}$ (see Appendix C), there is a (graded) $J R_{V}$-module homomorphism $\phi_{M}: J R_{V} \otimes_{R_{V}} R_{M} \rightarrow \operatorname{gr}_{F}(M)$ such that the following diagram commutes


Lemma 8.9. The (graded) $J R_{V}$-module homomorphism $\phi_{M}: J R_{V} \otimes_{R_{V}} R_{M} \rightarrow \operatorname{gr}_{F}(M)$ defined above is surjective.

Proof. The assertion follows from Lemma 8.3 and Theorem 8.8,
When $\phi_{M}$ is an isomorphism, we say $M$ is classically free.
Example $8.10\left(J R_{\mathrm{Vir}^{c}} \otimes_{R_{\mathrm{Vir}} \mathrm{c}} R_{M(c, h)}\right)$. We pick a highest weight $(c, h)$. The Verma module $M(c, h)$ is always classically free as a $\mathrm{Vir}^{c}$-module because by Example 7.6, Example 8.1 and Example 8.7,

$$
\begin{aligned}
J R_{\mathrm{Vir} c} \otimes_{R_{\mathrm{Vir}} c} R_{M(c, h)} & \cong \mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right] \otimes_{\mathbb{C}\left[L_{-2}\right]} \bigoplus_{k \in \mathbb{N}} \mathbb{C}\left[L_{-2}\right] L_{-1}^{k} \\
& \cong \bigoplus_{k \in \mathbb{N}} \mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right] L_{-1}^{k} \\
& \cong \operatorname{gr}_{F}(M(c, h)) .
\end{aligned}
$$

We wish to determine when the irreducible modules $L\left(c_{p, q}, h_{m, n}\right)$ over the simple Virasoro vertex algebras $\operatorname{Vir}_{p, q}$ are classically free, as mentioned in Theorem 0.3 and Theorem 6.3.

## 9. Proofs of the main theorems

In this section, we fix $s \in \mathbb{Z}_{+}$and $i \in\{1, \ldots, s\}$.
A partition $\lambda=\left[\lambda_{1}, \ldots, \lambda_{m}\right]$ contains a partition $\eta=\left[\eta_{1}, \ldots, \eta_{n}\right]$, written as $\eta \subseteq \lambda$, if $m \geq n$ and there is $i \in \mathbb{Z}_{+}$such that $1 \leq i \leq m-n+1$ and $\left[\lambda_{i}, \lambda_{i+1}, \ldots, \lambda_{i+n-1}\right]=\eta$.

We define

$$
p^{s, i}(t, q)=\sum_{\lambda \in P^{s, i}} t^{\operatorname{len}(\lambda)} q^{\Delta(\lambda)} \in \mathbb{C}[[t, q]],
$$

where $P^{s, i}$ is the set of partitions that do not contain any partition in $R^{s, i}$ as defined in $\$ 0$, i.e.,

$$
P^{s, i}=\left\{\lambda \vdash \mid \text { for } \eta \in R^{s, i}, \lambda \nsupseteq \eta\right\} .
$$

Lemma 9.1. We have

$$
p^{s, i}(t, q)=\sum_{k=\left(k_{1}, \ldots, k_{s-1}\right) \in \mathbb{N}^{s-1}} t^{k B_{s-1}^{(s)}} \frac{q^{\frac{1}{2} k G^{(s)} k^{T}+k B_{s-i}^{(s)}}}{(q)_{k_{1}} \ldots(q)_{k_{s-1}}} .
$$

Proof. Following the notation of And98, §7], we write:

$$
\begin{aligned}
p^{s, i}(t, q) & =\sum_{m=0}^{\infty} \sum_{n=0}^{\infty} b_{s, i}(m, n) t^{m} q^{n}, \\
J_{s, i}(0, t, q) & =\sum_{m=0}^{\infty} \sum_{n=0}^{\infty} c_{s, i}(m, n) t^{m} q^{n} .
\end{aligned}
$$

By And98, §7.3], we have $b_{s, i}(m, n)=c_{s, i}(m, n)$ for $m, n \in \mathbb{N}$. This means $p^{s, i}(t, q)=J_{s, i}(0, t, q)$.
By the proof of [And98, Theorem 7.8], we have

$$
J_{s, i}(0, t, q)=\sum_{k=\left(k_{1}, \ldots, k_{s-1}\right) \in \mathbb{N}^{s-1}} \frac{t^{N_{1}+\cdots+N_{s-1}} q^{N_{1}^{2}+\cdots+N_{s-1}^{2}+N_{i}+\cdots+N_{s-1}}}{(q)_{k_{1}} \cdots(q)_{k_{s-1}}}
$$

where $N_{j}=k_{j}+\cdots+k_{s-1}$ for $j=1, \ldots, s$. Since:

$$
\begin{aligned}
N_{1}^{2}+\cdots+N_{s-1}^{2} & =\frac{1}{2} k G^{(s)} k^{T} \\
N_{j}+\cdots+N_{s-1} & =k B_{s-j}^{(s)} \quad \text { for } j=1, \ldots, s
\end{aligned}
$$

we have

$$
\sum_{k=\left(k_{1}, \ldots, k_{s-1}\right) \in \mathbb{N}^{s-1}} \frac{t^{N_{1}+\cdots+N_{s-1}} q^{N_{1}^{2}+\cdots+N_{s-1}^{2}+N_{i}+\cdots+N_{s-1}}}{(q)_{k_{1}} \ldots(q)_{k_{s-1}}}=\sum_{k=\left(k_{1}, \ldots, k_{s-1}\right) \in \mathbb{N}^{s-1}} t^{k B_{s-1}^{(s)}} \frac{q^{\frac{1}{2} k G^{(s)} k^{T}+k B_{s-i}^{(s)}}}{(q)_{k_{1}} \cdots(q)_{k_{s-1}}} .
$$

Lemma 9.2. We have

$$
\operatorname{ch}_{L\left(c_{2,2 s+1}, h_{1, i}\right)}(q)=q^{h_{1, i}} p^{s, i}(1, q)=q^{h_{1, i}}\left(\prod_{\substack{n=1 \\ n \neq 0, \pm i}}^{\infty}\left(1-q^{n}\right)^{-1}\right) .
$$

Proof. By the proof of Lemma 9.1, And98, Lemma 7.3] and [And98, Corollary 2.9], we have

$$
\begin{aligned}
q^{h_{1, i}} p^{s, i}(1, q) & =q^{h_{1, i}} J_{s, i}(0,1, q) \\
& =q^{h_{1, i}}\left(\prod_{n \neq 0, \pm i}^{\infty}\left(1-q^{n}\right)^{-1}\right) \\
& =\frac{q^{h_{1, i}}}{(q)_{\infty}} \sum_{k \in \mathbb{N}}(-1)^{k} q^{(2 s+1) k(k+1) / 2-k i}\left(1-q^{(2 k+1) i}\right) \\
& =\frac{q^{h_{1, i}}}{(q)_{\infty}} \sum_{k \in \mathbb{Z}}(-1)^{k} q^{(2 s+1) k(k+1) / 2-k i} .
\end{aligned}
$$

The disjoint union $\mathbb{Z}=\{2 k \mid k \in \mathbb{Z}\} \cup\{-2 k-1 \mid k \in \mathbb{Z}\}$ and Theorem 6.4 imply that

$$
\begin{aligned}
\frac{q^{h_{1, i}}}{(q)_{\infty}} \sum_{k \in \mathbb{Z}}(-1)^{k} q^{(2 s+1) k(k+1) / 2-k i}= & \frac{q^{h_{1, i}}}{(q)_{\infty}}\left(\sum_{k \in \mathbb{Z}}(-1)^{2 k} q^{(2 s+1) 2 k(2 k+1) / 2-2 k i}\right. \\
& \left.+\sum_{k \in \mathbb{Z}}(-1)^{-2 k-1} q^{(2 s+1)(-2 k-1)(-2 k-1+1) / 2-(-2 k-1) i}\right) \\
= & \frac{q^{h_{1, i}}}{(q)_{\infty}}\left(\sum_{k \in \mathbb{Z}} q^{2 k^{2}(2 s+1)+k(2 s+1-2 i)}-\sum_{k \in \mathbb{Z}} q^{2 k^{2}(2 s+1)+k(2 s+2 i+1)+i}\right) \\
& =\operatorname{ch}_{L\left(c_{2,2 s+1}, h_{1, i}\right)}(q) .
\end{aligned}
$$

We order the PBW basis of $U\left(\operatorname{Vir}^{-}\right)=\operatorname{span}\left\{L_{\lambda} \mid \lambda \vdash\right\}$ by degree reverse lexicographic order with $L_{-1}>L_{-2}>\ldots$. Formally, for any partitions $\lambda$ and $\eta$, we define

$$
L_{\lambda} \leq L_{\eta} \text { if and only if } p_{\lambda} \leq p_{\eta} .
$$

For $x \in U\left(\mathrm{Vir}^{-}\right)$with $x \neq 0$, we may write

$$
x=c_{1} L_{\lambda^{1}}+c_{2} L_{\lambda^{2}}+\cdots+c_{r} L_{\lambda^{r}},
$$

where for $1 \leq i \leq r, 0 \neq c_{i} \in \mathbb{C}$ and $L_{\lambda^{1}}>L_{\lambda^{2}}>\cdots>L_{\lambda^{r}}$. We define the leading power of $x$ as $\operatorname{lp}(x)=L_{\lambda^{1}}$. We set $\operatorname{lp}(0)=0$. Next, for a highest weight $(c, h)$, we extend the definition of lp from $U\left(\mathrm{Vir}^{-}\right)$to $M(c, h)$ by considering the isomorphism of vector spaces $U\left(\operatorname{Vir}^{-}\right) \xrightarrow{\sim}$ $M(c, h), L_{\lambda} \mapsto L_{\lambda}|c, h\rangle$, where $\lambda$ is a partition.
Remark 9.3. The definition of the order in the PBW basis of $U\left(\mathrm{Vir}^{-}\right)$was made so that for a highest weight $(c, h)$, a partition $\lambda$ and $u \in M(c, h)$, if $\operatorname{lp}(u)=L_{\lambda}|c, h\rangle$, then $\operatorname{lp}\left(\gamma^{\operatorname{len}(\lambda)}(u)\right)=p_{\lambda}$.

Lemma 9.4. For $\lambda \in R^{s, i}$, there exists $u \in J\left(c_{2,2 s+1}, h_{1, i}\right)$ homogeneous such that $\operatorname{lp}(u)=$ $L_{\lambda}\left|c_{2,2 s+1}, h_{1, i}\right\rangle$.
Proof. By Theorem 6.1, the maximal proper ideal of $\mathrm{Vir}^{c_{2,2 s+1}}$ is generated by a singular vector of conformal weight $2 s$, denoted by $a_{2,2 s+1}$, which has the form

$$
\begin{equation*}
a_{2,2 s+1}=L_{-2}^{s}|0\rangle+\sum_{\substack{\mu \vdash 2 s \\ \mu \operatorname{len}(\mu) \geq 2 \\ \operatorname{len}(\mu)<s}} c_{\mu} L_{\mu}|0\rangle, \tag{9.1}
\end{equation*}
$$

where $c_{\mu} \in \mathbb{Q}$. We have two cases:
(i) $\lambda=\left[a^{d},(a+1)^{s-d}\right]$ for some $a \in \mathbb{Z}_{+}$and $d \in\{1, \ldots, s\}$. We set

$$
u=\left(a_{2,2 s+1}\right)_{(s-s a+d-1)}\left|c_{2,2 s+1}, h_{1, i}\right\rangle
$$

and claim

$$
\operatorname{lp}(u)=L_{\lambda}\left|c_{2,2 s+1}, h_{1, i}\right\rangle .
$$

To prove this, we first prove that

$$
\begin{equation*}
\left(L_{-2}^{s}|0\rangle\right)_{(s-s a+d-1)}\left|c_{2,2 s+1}, h_{1, i}\right\rangle=\binom{s}{d} L_{\lambda}\left|c_{2,2 s+1}, h_{1, i}\right\rangle+\sum_{\substack{\mu+\Delta(\lambda) \\ \operatorname{len}(\mu) \leq \operatorname{len}(\lambda) \\ \mu \neq \lambda}} c_{\mu} L_{\mu}\left|c_{2,2 s+1}, h_{1, i}\right\rangle, \tag{9.2}
\end{equation*}
$$

where $c_{\mu} \in \mathbb{Q}$. Applying Proposition 6.2 and Lemma 5.3 with:

$$
\begin{aligned}
a^{1}(z)=\cdots=a^{s}(z) & =L(z)=\sum_{n \in \mathbb{Z}} L_{(n)} z^{-n-1}=\sum_{n \in \mathbb{Z}} L_{n} z^{-n-2}, \\
b & =\left|c_{2,2 s+1}, h_{1, i}\right\rangle \\
l & =s-s a+d-1,
\end{aligned}
$$

we obtain

$$
\begin{equation*}
\left(L_{-2}^{s}|0\rangle\right)_{(l)}\left|c_{2,2 s+1}, h_{1, i}\right\rangle=\sum_{n_{1}, \ldots, n_{s-1} \in \mathbb{N}} \sum_{k=0}^{s-1} R_{n_{1}, \ldots, n_{s-1}}^{l, k}(L(z), \ldots, L(z))\left|c_{2,2 s+1}, h_{1, i}\right\rangle, \tag{9.3}
\end{equation*}
$$

where $R_{n_{1}, \ldots, n_{s-1}}^{l, k}(L(z), \ldots, L(z))$ is the sum of $\binom{s-1}{k}$ terms given by

$$
R_{n_{1}, \ldots, n_{s-1}}^{l, k}(L(z), \ldots, L(z))=
$$

where

$$
\begin{aligned}
& L_{\left(-n_{j_{1}}-1\right)} \ldots L_{\left(-n_{j_{s-1-k}}-1\right)} L_{\left(l-k-\sum_{r=1}^{k} n_{i_{r}}+\sum_{r=1}^{s-1-k} n_{j_{r}}\right)} L_{\left(n_{i_{k}}\right)} \ldots L_{\left(n_{\left.i_{1}\right)}\right)}= \\
& L_{-n_{j_{1}}-2} \ldots L_{-n_{j_{s-1-k}}-2} L_{s-s a+d-2-k-\sum_{r=1}^{k} n_{i_{r}}+\sum_{r=1}^{s-1-k} n_{j_{r}}} L_{n_{i_{k}}-1} \ldots L_{n_{i_{1}-1}-1} .
\end{aligned}
$$

We see that each term $L_{\mu}$ appearing in $R_{n_{1}, \ldots, n_{s-1}}^{l, k}(L(z), \ldots, L(z)$ ), where $\mu$ is a combination (not necessarily a partition), satisfies $\Delta(\mu)=s a+s-d=\Delta(\lambda)$ and len $(\mu) \leq \operatorname{len}(\lambda)$.

We recall that $L_{\lambda}-L_{\lambda \sigma} \in U\left(\operatorname{Vir}^{-}\right)^{\operatorname{len}(\lambda)-1}$ for a combination $\lambda$ and a permutation $\sigma \in S_{\operatorname{len}(\lambda)}$ (see [Dix96, §2] for details). Therefore, for a combination $\mu$, we can expand $L_{\mu}\left|c_{2,2 s+1}, h_{1, i}\right\rangle$ in the following way

$$
L_{\mu}\left|c_{2,2 s+1}, h_{1, i}\right\rangle=L_{\mathrm{prt}(\mu)}\left|c_{2,2 s+1}, h_{1, i}\right\rangle+\sum_{\substack{\mu+\Delta(\lambda) \\ \operatorname{len}(\mu)<\operatorname{len}(\lambda)}} c_{\mu} L_{\mu}\left|c_{2,2 s+1}, h_{1, i}\right\rangle,
$$

where $c_{\mu} \in \mathbb{Q}$. We need to compute the coefficient of $L_{\lambda}\left|c_{2,2 s+1}, h_{1, i}\right\rangle$ in $u$ when expressed as a linear combination of the elements of the usual PBW basis. To do this, we need to see how much each sum $R_{n_{1} \ldots, n_{s-1}}^{l, k}(L(z), \ldots, L(z))\left|c_{2,2 s+1}, h_{1, i}\right\rangle$ contributes to the coefficient of $L_{\lambda}\left|c_{2,2 s+1}, h_{1, i}\right\rangle$ in $u$. We have two subcases:
Subcase $a=1$ : In the sum (9.3), if $k>d$ or $k<d-1$ or $n_{i} \neq 0$ for some $i=1, \ldots, s-1$, then $R_{n_{1}, \ldots, n_{s-1}}^{l, k}(L(z), \ldots, L(z))\left|c_{2,2 s+1}, h_{1, i}\right\rangle$ contributes 0 . As for the two remaining sums, the sum $R_{0, \ldots, 0}^{l, d-1}(L(z), \ldots, L(z))\left|c_{2,2 s+1}, h_{1, i}\right\rangle$ contributes $\binom{s-1}{d-1}$ because we are picking $d-1$ elements from $\{1, \ldots, s-1\}$, and the sum $R_{0, \ldots, 0}^{l, d}(L(z), \ldots, L(z))\left|c_{2,2 s+1}, h_{1, i}\right\rangle$ contributes $\binom{s-1}{d}$ because we are picking $d$ elements from $\{1, \ldots, s-1\}$. Since $\binom{s-1}{d-1}+$ $\binom{s-1}{d}=\binom{s}{d}$, we obtain (9.2).
Subcase $a>1$ : In the sum (9.3), if $k>0$, then $R_{n_{1}, \ldots, n_{s-1}}^{l, k}(L(z), \ldots, L(z))\left|c_{2,2 s+1}, h_{1, i}\right\rangle$ contributes 0 . We have

$$
R_{n_{1}, \ldots, n_{s-1}}^{l, 0}(L(z), \ldots, L(z))=L_{-n_{1}-2} \ldots L_{-n_{s-1}-2} L_{s-s a+d-2+\sum_{r=1}^{s-1} n_{r}} .
$$

Therefore, the sum $R_{n_{1}, \ldots, n_{s-1}}^{l, 0}(L(z), \ldots, L(z))\left|c_{2,2 s+1}, h_{1, i}\right\rangle$ contributes $\binom{s-1}{d-1}$ when exactly $d-1$ of the $n_{i} \mathrm{~S}$ are equal to $a-2$ and $s-d$ of the $n_{i}$ s are equal to $a-1$, contributes $\binom{s-1}{d}$ when exactly $d$ of the $n_{i}$ s are equal to $a-2$ and $s-d-1$ of the $n_{i}$ s are equal to $a-1$ and contributes 0 otherwise. Since $\binom{s-1}{d-1}+\binom{s-1}{d}=\binom{s}{d}$, we obtain (9.2).
(ii) $\lambda=\left[1^{i}\right]$. This follows from [BSA88], where it is proved that one of the generating singular vectors in $J\left(c_{2,2 s+1}, h_{1, i}\right)$ contains the term $\left.L_{-1}^{i} \mid c_{2,2 s+1}, h_{1, i}\right)$ in its expansion with respect to the usual PBW basis.
We note that if $\mu$ is a partition of $\Delta(\lambda)$ such that $\operatorname{len}(\mu) \leq \operatorname{len}(\lambda)$ and $\mu \neq \lambda$, then $L_{\lambda}>$ $L_{\mu}$. Thus, (9.2) implies $\operatorname{lp}\left(\left(L_{-2}^{s}|0\rangle\right)_{(s-s a+d-1)}\left|c_{2,2 s+1}, h_{1, i}\right\rangle\right)=L_{\lambda}\left|c_{2,2 s+1}, h_{1, i}\right\rangle$. From (9.1) and Lemma 5.3, we see that $\operatorname{lp}(u)=\operatorname{lp}\left(\left(L_{-2}^{s}|0\rangle\right)_{(s-s a+d-1)}\left|c_{2,2 s+1}, h_{1, i}\right\rangle\right)=L_{\lambda}\left|c_{2,2 s+1}, h_{1, i}\right\rangle$. Finally, by Theorem 6.3, $u \in J\left(c_{2,2 s+1}, h_{1, i}\right)$, and it is clear that $u$ is homogeneous from its definition.

Remark 9.5. For any partitions $\lambda$ and $\eta$, if $\lambda \supseteq \eta$, then $p_{\eta} \mid p_{\lambda}$. The converse is not true. For example, $p_{[4,2]} \mid p_{[4,3,2]}$, but $[4,3,2] \nsupseteq[4,2]$. However, if $\eta=\left[\eta_{1}, \ldots, \eta_{m}\right]$ and $\eta_{1}-\eta_{m} \leq 1$, then $\lambda \supseteq \eta$ if and only if $p_{\eta} \mid p_{\lambda}$.

Lemma 9.6. There is an alternative description for $P^{s, i}$, namely

$$
P^{s, i}=\left\{\lambda \vdash \mid \text { for } \eta \in R^{s, i}, p_{\eta} \nmid p_{\lambda}\right\} .
$$

Proof. This is a consequence of Remark 9.5.
Sketch of proof of Theorem 0.2. Let $G$ be a Gröbner basis of $K\left(c_{2,2 s+1}, h_{1, i}\right)$, and we set:

$$
\begin{aligned}
B & =\left\{p_{\lambda} \mid \text { for } a \in G, \operatorname{lp}(a) \nmid p_{\lambda}\right\}, \\
\bar{B} & =\left\{p_{\lambda} \mid \lambda \in P^{s, i}\right\} .
\end{aligned}
$$

By Gröbner basis theory, (4.1), Remark 9.3, Lemma 9.4 and Lemma 9.6, we have $\bar{B} \subseteq B$. Actually, Proposition 4.6 and Lemma 9.2 imply $\bar{B}=B$. We have found a basis of $\operatorname{gr}\left(L\left(c_{2,2 s+1}, h_{1, i}\right)\right)$ and by Proposition 4.6, a basis of $L\left(c_{2,2 s+1}, h_{1, i}\right)$. For details, see [Sal24].
Proof of Theorem 0.1. This is a corollary of Theorem 0.2, see Sal24 for details.
Proof of Theorem 0.3. By Example 8.7, we have

$$
R_{L\left(c_{2,2 s+1}, h_{1, i}\right)} \cong \frac{\bigoplus_{k \in \mathbb{N}} \mathbb{C}\left[L_{-2}\right] L_{-1}^{k}}{\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right)} \cong \frac{\mathbb{C}\left[L_{-2}, L_{-1}\right]}{\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right)}
$$

First, we prove that for a partition $\eta$ with $\eta=\emptyset$ or $2 \geq \eta_{1}$,

p_{\eta}+\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right) \in \operatorname{span}\left\{p_{\lambda}+\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right) \mid \lambda=\emptyset \text { or }\left(\lambda \in P^{s, i} \text { and } 2 \geq \lambda_{1}\right)\right\}=W
$$

We assume, for the sake of contradiction, that there is a power $p_{\eta}$ with $\eta=\emptyset$ or $2 \geq \eta_{1}$ not satisfying $p_{\eta}+\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right) \in W$.

Let $p_{\eta_{0}}$ be the smallest of such powers in the degree reverse lexicographic order with $L_{-1}>$ $L_{-2}>\ldots$. We must have $\eta_{0} \neq \emptyset$ and $\eta_{0} \notin P^{s, i}$, otherwise $p_{\eta_{0}}+\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right) \in W$. By Lemma 9.6, there is $\mu \in R^{s, i}$ such that $p_{\mu} \mid p_{\eta_{0}}$. From (4.1), Remark 9.3, Lemma 9.4 and the fact that lp is multiplicative, we obtain $u \in J\left(c_{2,2 s+1}, h_{1, i}\right)$ homogeneous such that $\operatorname{lp}(u)=L_{\eta_{0}}\left|c_{2,2 s+1}, h_{1, i}\right\rangle$.

From the equation

$$
u=L_{\eta_{0}}\left|c_{2,2 s+1}, h_{1, i}\right\rangle+\sum_{\substack{\mu \vdash \Delta\left(\eta_{0}\right) \\ L_{\mu}<L_{\eta_{0}}}} c_{\mu} L_{\mu}\left|c_{2,2 s+1}, h_{1, i}\right\rangle,
$$

where $c_{\mu} \in \mathbb{Q}$, we obtain

$$
p_{\eta_{0}}+\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right)=-\sum_{\substack{\mu \vdash \Delta\left(\eta_{0}\right) \\ p_{\mu}<\eta_{0} \\ 2 \geq \mu_{1}}} c_{\mu}\left(p_{\mu}+\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right)\right) .
$$

The last equation implies $p_{\eta_{0}}+\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right) \in W$ because $p_{\mu}+\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right) \in W$ if $p_{\mu}<p_{\eta_{0}}$ by the minimality of $p_{\eta_{0}}$, and this is a contradiction. We have proved that

$$
\begin{equation*}
\frac{\mathbb{C}\left[L_{-2}, L_{-1}\right]}{\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right)}=\operatorname{span}\left\{p_{\lambda}+\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right) \mid \lambda=\emptyset \text { or }\left(\lambda \in P^{s, i} \text { and } 2 \geq \lambda_{1}\right)\right\} . \tag{9.4}
\end{equation*}
$$

By [VEH21] or BMS13], we already know $\operatorname{Vir}_{2,2 s+1}$ is classically free. This means that $\operatorname{gr}_{F}\left(\operatorname{Vir}_{2,2 s+1}\right) \cong J R_{\operatorname{Vir}_{2,2 s+1}} \cong J\left(\mathbb{C}\left[L_{-2}\right] /\left(L_{-2}^{s}\right)\right)=\mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right] /\left(L_{-2}^{s}\right)_{\partial}$ and

$$
\begin{equation*}
\mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right] /\left(L_{-2}^{s}\right)_{\partial}=\bigoplus_{\lambda \in P^{s, 1}} \mathbb{C}\left(p_{\lambda}+\left(L_{-2}^{s}\right)_{\partial}\right) \tag{9.5}
\end{equation*}
$$

We have

$$
\begin{equation*}
\left.J R_{\mathrm{Vir}_{2,2 s+1}} \otimes_{R_{\mathrm{Vir}_{2}, 2 s+1}} R_{L\left(c_{2}, 2 s+1\right.}, h_{1, i}\right) \mathrm{C} \frac{\mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right]}{\left(L_{-2}^{s}\right)_{\partial}} \otimes_{\frac{\mathrm{c}\left[L_{-2]}\right]}{\left(L_{-2}^{s}\right)}} \frac{\mathbb{C}\left[L_{-2}, L_{-1}\right]}{\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right)} \tag{9.6}
\end{equation*}
$$

Given a partition $\lambda \in P^{s, i}$, we can write $\lambda$ uniquely as $\lambda=\left[\lambda^{1}, \lambda^{2}\right]$, where $\lambda^{1} \in P^{s, 1}$ satisfies $\lambda^{1}=\emptyset$ or $\lambda_{\operatorname{len}\left(\lambda^{1}\right)}^{1} \geq 3$ and $\lambda^{2}=\emptyset$ or $\left(\lambda^{2} \in P^{s, i}\right.$ and $\left.2 \geq \lambda_{1}^{2}\right)$.

Given $\lambda \in P^{s, i}$, we define

$$
t_{\lambda}=\left(p_{\lambda^{1}}+\left(L_{-2}^{s}\right)_{\partial}\right) \otimes\left(p_{\lambda^{2}}+\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right)\right) \in \frac{\mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right]}{\left(L_{-2}^{s}\right)_{\partial}} \otimes_{\frac{\mathfrak{c}\left[L_{-2}\right]}{\left(L_{-2}^{s}\right)}} \frac{\mathbb{C}\left[L_{-2}, L_{-1}\right]}{\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right)}
$$

From (9.4), (9.5) and (9.6), we conclude that

$$
\begin{equation*}
J R_{\mathrm{Vir}_{2,2 s+1}} \otimes_{\mathrm{Vii}_{2,2 s+1}} R_{L\left(c_{2,2 s+1}, h_{1, i}\right)}=\operatorname{span}\left\{t_{\lambda} \mid \lambda \in P^{s, i}\right\} . \tag{9.7}
\end{equation*}
$$

By Theorem 0.2 and Proposition 4.6 with $\mathrm{gr}_{F}$ instead of gr, the natural epimorphism $\phi_{L\left(c_{2,2 s+1}, h_{1, i}\right)}$ maps the set $\left\{t_{\lambda} \mid \lambda \in P^{s, i}\right\}$ onto a basis of $\operatorname{gr}_{F}\left(L\left(c_{2,2 s+1}, h_{1, i}\right)\right)$. Thus, the set $\left\{t_{\lambda} \mid \lambda \in P^{s, i}\right\}$ is
linearly independent, and by (9.7), it is a basis of $J R_{\mathrm{Vir}_{2,2 s+1}} \otimes_{R_{\mathrm{Vir}_{2}, 2 s+1}} R_{L\left(c_{2,2 s+1}, h_{1, i}\right)}$. Therefore, $\phi_{L\left(c_{2,2 s+1}, h_{1, i}\right)}$ is an isomorphism, and $L\left(c_{2,2 s+1}, h_{1, i}\right)$ is classically free.

Let $p, q>2$ be relatively prime integers, and let $m, n$ be integers such that $0<m<p$ and $0<$ $n<q$. We have two natural inclusions inc : $\left.J R_{\operatorname{Vir}_{p, q}} \hookrightarrow J R_{\operatorname{Vir}_{p, q}} \otimes_{R_{\mathrm{Virir}_{p}, q}} R_{L\left(c_{p}, q\right.}, h_{m, n}\right), \operatorname{inc}(a)=a \otimes 1$ and inc : $\operatorname{gr}_{F}\left(\operatorname{Vir}_{p, q}\right) \hookrightarrow \operatorname{gr}_{F}\left(L\left(c_{p, q}, h_{m, n}\right)\right), \operatorname{inc}(a)=a 1$. We assume, for the sake of contradiction, that $\phi_{L\left(c_{p, q}, h_{m, n}\right)}$ is an isomorphism. This would imply that $\phi_{\operatorname{Vir}_{p, q}}$ is also an isomorphism, a contradiction to Example 8.5. Finally, $\phi_{L\left(c_{p, q}, h_{m, n}\right)}$ is not an isomorphism, and $L\left(c_{p, q}, h_{m, n}\right)$ is not classically free as a module over $\operatorname{Vir}_{p, q}$.

As in the proof of Lemma 9.4, let $w \in J\left(c_{2,2 s+1}, h_{1, i}\right)$ be the singular vector such that $\operatorname{lp}(w)=$ $L_{-1}^{i}\left|c_{2,2 s+1}, h_{1, i}\right\rangle$, and we set:

\begin{array}{ll}
u_{k}=\sigma_{0}\left(\left(a_{2,2 s+1}\right)_{(k-1)}\left|c_{2,2 s+1}, h_{1, i}\right\rangle\right) \quad \text { for } k=1, \ldots, i-1, \\
u_{i} & =\sigma_{0}(w) .
\end{array}
$$

Then $u_{1}, \ldots, u_{i} \in \sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right)$. Moreover:

$$
\begin{aligned}
L_{-2}^{s} & =\sigma_{0}\left(a_{2,2 s+1}\right) \sigma_{0}\left(\left|c_{2,2 s+1}, h_{1, i}\right\rangle\right)=\sigma_{0}\left(\left(a_{2,2 s+1}\right)_{(-1)}\left|c_{2,2 s+1}, h_{1, i}\right\rangle\right) \in \sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right) \\
\operatorname{lp}\left(u_{k}\right) & =L_{-2}^{s-k} L_{-1}^{k} \quad \text { for } k=1, \ldots, i-1 \\
\operatorname{lp}\left(u_{i}\right) & =L_{-1}^{i} .
\end{aligned}
$$

Corollary 9.7. With the notation above, we have:

\begin{align*}
\sigma_{0}\left(J\left(c_{2,2 s+1}, h_{1, i}\right)\right) & =\left(L_{-2}^{s}, u_{1}, \ldots, u_{i}\right)_{\mathrm{psn}},  \tag{9.8}\\
R_{L\left(c_{2,2 s+1}, h_{1, i}\right)} & \cong \frac{\bigoplus_{k \in \mathbb{N}} \mathbb{C}\left[L_{-2}\right] L_{-1}^{k}}{\left(L_{-2}^{s}, u_{1}, \ldots, u_{i}\right)_{\mathrm{psn}}^{k}},  \tag{9.9}\\
\operatorname{gr}_{F}\left(L\left(c_{2,2 s+1}, h_{1, i}\right)\right) & \cong \frac{\mathbb{C}\left[L_{-2}, L_{-3}, \ldots\right]}{\left(L_{-2}^{s}\right)_{\partial}} \otimes \frac{\mathrm{c}\left(L_{-2}\right]}{\left(L_{-2}^{s}\right)} \frac{\bigoplus_{k \in \mathbb{N}} \mathbb{C}\left[L_{-2}\right] L_{-1}^{k}}{\left(L_{-2}^{s}, u_{1}, \ldots, u_{i}\right)_{\mathrm{psn}}}, \tag{9.10}
\end{align*}
$$

where psn denotes the Poisson submodule generated by the given subset.
Proof. We use the notation of the proof of Theorem 0.3. Since $\left\{t_{\lambda} \mid \lambda \in P^{s, i}\right\}$ is a basis of $J R_{\mathrm{Vir}_{2,2 s+1}} \otimes_{\mathrm{V}_{\mathrm{Vir}_{2}, 2 s+1}} R_{L\left(c_{2,2 s+1}, h_{1, i}\right)}$, the set in (9.4) is a basis of $R_{L\left(c_{2,2 s+1}, h_{1, i}\right)}$. We note that for a partition $\lambda \in R^{s, i}$ with $2 \geq \lambda_{1}$, there is $u \in\left(L_{-2}^{s}, u_{1}, \ldots, u_{i}\right)_{\text {psn }}$ such that $\operatorname{lp}(u)=u_{\lambda}$. Therefore, we can prove (9.8) similarly to how we proved (9.4). The isomorphisms (9.9) and (9.10) follow.

Remark 9.8. We have

$$
u_{1}=\sigma_{0}\left(\left(a_{2,2 s+1}\right)_{(0)}\left|c_{2,2 s+1}, h_{1, i}\right\rangle\right)=\left\{\sigma_{0}\left(a_{2,2 s+1}\right), \sigma_{0}\left(\left|c_{2,2 s+1}, h_{1, i}\right\rangle\right)\right\}=\left\{L_{-2}^{s}, 1\right\}=s L_{-2}^{s-1} L_{-1} .
$$

However, I think there is no simple expression for $u_{2}, \ldots, u_{i}$ and $R_{L\left(c_{2,2 s+1}, h_{1, i}\right)}$.

## Appendix A. Graded Poisson algebras and their modules

Let $A$ be a commutative associative algebra. A Hamiltonian operator of $A$ is a diagonalizable operator $H \in \operatorname{End}(A)$ such that

H(a b)=H(a) b+a H(b) \quad \text { for } a, b \in A .
$$

Thus, a Hamiltonian of $A$ is just a derivation of $A$. An algebra with a Hamiltonian is called graded.

Let $A$ be a differential commutative associative algebra with derivation $\partial$. A Hamiltonian operator of $A$ is a Hamiltonian of $A$ as a commutative associative algebra such that

[H, \partial]=\partial
$$

It is possible to prove inductively that the last equation implies

$$
\begin{equation*}
H \partial^{n}=n \partial^{n}+\partial^{n} H \quad \text { for } n \in \mathbb{N} . \tag{A.1}
\end{equation*}
$$

Let $A$ be a Poisson algebra as defined in [Car03. A Hamiltonian operator of $A$ is a Hamiltonian $H$ of $A$ as a commutative associative algebra such that

$$
H(\{a, b\})=\{a, H(b)\}+\{H(a), b\}-\{a, b\} \quad \text { for } a, b \in A .
$$

Let $A$ be a graded commutative associative algebra with Hamiltonian $H$, and let $M$ be an A-module. If $A$ has a unit 1 , we further assume that $1 u=u$ for $u \in M$. A Hamiltonian operator of $M$ is a diagonalizable operator $H^{M} \in \operatorname{End}(M)$ such that

$$
H^{M}(a u)=H(a) u+a H^{M}(u) \quad \text { for } a \in A \text { and } u \in M .
$$

Let $A$ be a Poisson algebra. A module over $A$ is an $A$-module $M$ in the usual associative sense equipped with a bilinear map $\{\bullet, \bullet\}: A \times M \rightarrow M$, which makes $M$ a Lie algebra module over $A$ such that for $a, b \in A$ and $u \in M$ :
(i) (Left Leibniz rule) $\{a, b u\}=\{a, b\} u+b\{a, u\}$;
(ii) (Right Leibniz rule) $\{a b, u\}=a\{b, u\}+b\{a, u\}$.

Let $A$ be a graded Poisson algebra with Hamiltonian $H$, and let $M$ be an $A$-module. A Hamiltonian operator of $M$ is a Hamiltonian $H^{M}$ of $M$ as a module over $A$ as a commutative associative algebra such that

$$
H^{M}(\{a, u\})=\left\{a, H^{M}(u)\right\}+\{H(a), u\}-\{a, u\} \quad \text { for } a \in A \text { and } u \in M
$$

## Appendix B. Graded Jet algebras and their modules

In this appendix, by an algebra we will mean a commutative associative algebra with unit. Let $R$ be a finitely generated algebra. We now construct a differential algebra $J R$ called the jet algebra of $R$ and an algebra inclusion inc : $R \hookrightarrow J R$ universal with this property, i.e., for a differential algebra $A$ and an algebra homomorphism $\phi: R \rightarrow A$, there is a unique differential algebra homomorphism $\bar{\phi}: J R \rightarrow A$ such that the following diagram commutes


Assuming $R=\mathbb{C}\left[x^{1}, \ldots, x^{r}\right] /\left(f_{1}, \ldots, f_{s}\right)$ for some polynomials $f_{1}, \ldots, f_{s} \in \mathbb{C}\left[x^{1}, \ldots, x^{r}\right]$, the construction is as follows. We introduce new variables $x_{(-i)}^{j}$ for $i=1,2, \ldots, j=1, \ldots, r$ and a derivation $\partial$ of the polynomial algebra $\mathbb{C}\left[x_{(-i)}^{j} \mid i=1,2, \ldots, j=1, \ldots, r\right]$ by setting

$$
\partial x_{(-i)}^{j}=i x_{(-i-1)}^{j} \quad \text { for } i=1,2, \ldots, j=1, \ldots, r .
$$

We set (identifying $x^{j}$ with $x_{(-1)}^{j}$ when considering $f_{i}$ in the following equation)

$$
\begin{aligned}
J R & =\mathbb{C}\left[x_{(-i)}^{j} \mid i=1,2, \ldots, j=1, \ldots, r\right] /\left(\partial^{j} f_{i} \mid i=1, \ldots, s, j=0,1, \ldots\right) \\
& =\mathbb{C}\left[x_{(-i)}^{j} \mid i=1,2, \ldots, j=1, \ldots, r\right] /\left(f_{1}, \ldots, f_{s}\right)_{\partial}
\end{aligned}
$$

where the subscript $\partial$ indicates the differential subalgebra generated by the given subset. By our definitions, $\partial$ factors through a derivation of $J R$, and we have an algebra inclusion inc : $R \hookrightarrow$ $J R, \operatorname{inc}\left(x^{j}+\left(f_{1}, \ldots, f_{s}\right)\right)=x_{(-1)}^{j}+\left(f_{1}, \ldots, f_{s}\right)_{\partial}$ for $j=1, \ldots, r$. The fact that inc : $R \hookrightarrow J R$ satisfies our desired universal property is explained in [Ara12, §2.3] and [EM09].
Remark B.1. We see that the classes of the original variables $x^{j}$ generate $J R$ as a differential algebra, i.e.,

$$
J R=\left(x^{1}+\left(f_{1}, \ldots, f_{s}\right)_{\partial}, \ldots, x^{r}+\left(f_{1}, \ldots, f_{s}\right)_{\partial}\right)_{\partial}
$$

If $f: R_{1} \rightarrow R_{2}$ is a homomorphism of finitely generated algebras, then $J f: J R_{1} \rightarrow J R_{2}$ is defined by requiring that $J f\left(\partial_{1}^{n}\left(\operatorname{inc}_{1}(x)\right)\right)=\partial_{2}^{n}\left(\operatorname{inc}_{2}(f(x))\right)$ for $x \in R_{1}$ and $n \in \mathbb{N}$ (cf. Remark B.1). For a finitely generated algebra $R$ and a differential algebra $A$, we have a natural isomorphism

$$
\operatorname{Hom}_{\{\text {differential algebras }\}}(J R, A) \cong \operatorname{Hom}_{\{\text {algebras }\}}(R, A)
$$

Remark B.2. It is not true that we have defined a functor $J$ which is left adjoint to the forgetful functor \{differential algebras\} $\rightarrow$ \{finitely generated algebras\} because a differential algebra is generally not finitely generated.

But we can easily work in the general case as follows. Let $R$ be an algebra (not necessarily finitely generated), and we consider the polynomial algebra in $R$ variables $\mathbb{C}\left[\left(x^{j}\right)_{j \in R}\right]$. We have a natural epimorphism $\pi: \mathbb{C}\left[\left(x^{j}\right)_{j \in R}\right] \rightarrow R, \pi\left(x^{j}\right)=j$ for $j \in R$. We can repeat the construction of $J R$ with $\mathbb{C}\left[\left(x^{j}\right)_{j \in R}\right]$ in place of $\mathbb{C}\left[x^{1}, \ldots, x^{r}\right]$ and $\operatorname{ker}(\pi)$ in place of $\left(f_{1}, \ldots, f_{s}\right)$. This way, we construct a functor

$$
J:\{\text { algebras }\} \rightarrow \text { differential algebras }\}
$$

which is left adjoint to the forgetful functor $\{$ differential algebras $\} \rightarrow$ \{algebras $\}$.
Given an algebra $R$, it is useful to consider the functor

$$
J R \otimes_{R} \bullet: R \text {-Mod } \rightarrow J R \text {-Mod, }
$$

where $J R$ is merely considered an algebra. Again, the $J R$-module $M$ together with the $R$ module inclusion inc : $M \hookrightarrow J R \otimes_{R} M, \operatorname{inc}(u)=1 \otimes u$ satisfy a universal property similar to that of inc : $R \hookrightarrow J R$, and the functor $J R \otimes_{R} \bullet$ is left adjoint to the forgetful functor $J R$-Mod $\rightarrow R$-Mod.

Let $R$ be a graded algebra with Hamiltonian $H$. We can extend uniquely the Hamiltonian $H$ to a Hamiltonian $H^{J R} \in \operatorname{End}(J R)$ because of (A.1). Furthermore, if $M$ is a graded $R$-module with Hamiltonian $H^{M}$, we can define a Hamiltonian of $J R \otimes_{R} M$ by setting

$$
H^{J R \otimes_{R} M}=H^{J R} \otimes \mathrm{Id}_{M}+\mathrm{Id}_{J R} \otimes H^{M}
$$

## Appendix C. Graded vertex Poisson algebras and their modules

Proposition C. 1 (Ara12, Proposition 2.3.1] and Appendix B). Let $R$ be a (graded) Poisson algebra. Then there is a unique (graded) vertex Poisson algebra structure on $J R$ such that

$$
a_{(n)} b=\delta_{n, 0}\{a, b\} \quad \text { for } a, b \in R \text { and } n \in \mathbb{N} \text {. }
$$

The (graded) vertex Poisson algebra structure on $J R$ given in Proposition C. 1 for a (graded) Poisson algebra $R$ will be called the level 0 vertex Poisson algebra structure of $J R$.

If $R$ is a (graded) Poisson algebra, and $M$ is a (graded) $R$-module, then we can verify that $J R \otimes_{R} M$ is a (graded) $J R$-module by defining the Poisson structure as

$$
a_{(n)}(b \otimes u)=\left(a_{(n)} b\right) \otimes u+\delta_{n, 0} b \otimes\{a, u\} \quad \text { for } a \in R, b \in J R, u \in M \text { and } n \in \mathbb{N}
$$

and $H^{J R \otimes_{R} M}$ as in Appendix B.
The (graded) $R$-module $M$ together with the natural (graded) $R$-module inclusion inc : $M \hookrightarrow$ $J R \otimes_{R} M$ satisfy the following universal property. Let $N$ be a (graded) module over the (graded) vertex Poisson algebra $J R$, and let $f: M \rightarrow N$ be a (graded) homomorphism of modules over the (graded) Poisson algebra $R$. There is a unique (graded) homomorphism $\bar{f}: J R \otimes_{R} M \rightarrow N$ of (graded) modules over the (graded) vertex Poisson algebra $J R$ such that the following diagram commutes
