# AUTOMORPHISM GROUPS OF CERTAIN ORBIFOLD VERTEX OPERATOR ALGEBRAS ARISING FROM COINVARIANT LATTICES ASSOCIATED WITH THE LEECH LATTICE

#### Abstract

We determine the automorphism groups of the orbifold vertex operator algebras associated with the coinvariant lattices of isometries of the Leech lattice in the conjugacy classes $3 C, 5 C, 11 A$ and $23 A$. These orbifold vertex operator algebras appear in a classification given by C.H. Lam and H. Shimakura.


## 1. Introduction

The orbifold of a vertex operator algebra (VOA) for an automorphism group is the fixed-points subVOA. We have a question: Are all automorphisms of its orbifold VOA obtained from the original VOA? Let us explain it precisely. For a VOA $V$ and an automorphism group $G$ of $V, V^{G}$ is defined by the set of all fixed-points. Let $V$ be simple and let $G$ be a cyclic subgroup generated by a finite order automorphism of $V$. We have a group homomorphism from the normalizer $N_{\text {Aut }(V)}(G)$ to Aut $\left(V^{G}\right)$. The main question is if the automorphism group Aut $\left(V^{G}\right)$ is isomorphic to a quotient group of $N_{\text {Aut }(V)}(G)$ or not. An automorphism of $V^{G}$ is called extra if it cannot be obtained from the image of the normalizer $N_{\text {Aut }(V)}(G)$. It is important to consider when the orbifold VOA has extra automorphisms.

The lattice VOA $V_{L}$ with respect to a positive-definite even lattice $L$ is a significant example of VOA. Let $g$ be a fixed-point free isometry of $L$. Then $g$ can be lifted to an element $\hat{g}$ of $\operatorname{Aut}\left(V_{L}\right)$. When $L$ has no root, the automorphism group $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$ is a finite group. We focus on such cases. In this paper, we consider the group structures of the automorphism groups of such orbifold VOAs.

The case that the order of $g$ is 2 , that is, $g$ is the -1 -isometry, has been studied in [Sh04]; $V_{L}^{\hat{g}}$ has extra automorphisms if and only if $L$ can be constructed by Construction B from a doubly even binary code.

In [LS24], the case that $g$ is a fixed-point free isometry of odd prime order $p$ was treated and Lam and Shimakura classified all rootless even lattices such that $V_{L}^{\hat{g}}$ has extra automorphisms. As to the above, Lam and Shimakura also classified rootless even lattices $L$ such that the $\tau$-conjugate $V_{L}(1) \circ \tau$ is of twisted type for some $\tau \in \operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$,
where $V_{L}(1)$ is the module defined in (3.2) (see Definition 2.4 for the definition of $\left.V_{L}(1) \circ \tau\right)$. The following is the classification.

Theorem 1.1. ([LS24, Main Corollary 1]) Let L be a positive-definite rootless even lattice. Let $g$ be a fixed-point free isometry of $L$ of prime order $p$ and let $\hat{g}$ be a standard lift of $g$. Then the following are equivalent:

- There exists an automorphism $\tau$ of $V_{L}^{\hat{g}}$ such that $V_{L}(1) \circ \tau$ is of twisted type;
- L is isometric to the coinvariant lattice $\Lambda_{p X}$ of the Leech lattice $\Lambda$ associated with the conjugacy class $p X \in\{2 A,-2 A, 3 B, 3 C, 5 B, 5 C, 7 B, 11 A, 23 A\}$.

In CLS18, La22+, Sh04, the automorphism groups associated with $2 A,-2 A, 3 B, 5 B$ and $7 B$ were determined. So far the others have not been determined.

In this paper, we determine all of the remaining automorphism groups of the orbifold VOAs $V_{\Lambda_{p X}}^{\hat{g}}$, where $p X \in\{3 C, 5 C, 11 A, 23 A\}$. To determine the automorphism groups, we prove a generalization of [Sh04, Lemma 3.7](Theorem 5.1):

Main Theorem 1. Let $L$ be a positive-definite rootless even lattice and let p be a prime number. Let $g$ be a fixed-point free isometry of $L$. If $(1-g) L^{*} \subset L$, then we have the following exact sequence

1 \longrightarrow A \longrightarrow \operatorname{Ker} \mu \xrightarrow{\tilde{\varphi}} B \longrightarrow 1
$$

where $A=\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{p}\right), B=\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle$ and the group homomorphism $\mu$ is as in (5.1).

The following theorem describes the group structures of the remaining automorphism groups of the orbifold VOAs.

Main Theorem 2. Let $(g, L) \in\left\{\left(3 C, \Lambda_{3 C}\right),\left(5 C, \Lambda_{5 C}\right),\left(11 A, \Lambda_{11 A}\right),\left(23 A, \Lambda_{23 A}\right)\right\}$ and let $\hat{g}$ be a lift of $g$ as in Subsection 2.4. Then the automorphism groups of orbifold VOAs $V_{L}^{\hat{g}}$ are following:

- $\left.\operatorname{Aut}\left(V_{\Lambda_{3 C}}^{\hat{g}}\right) \cong\left(3^{4} \cdot\left(3^{4}: 2\right)\right) \cdot\left(\Omega_{7}(3) \cdot 2\right)\right)$;
- $\operatorname{Aut}\left(V_{\Lambda_{5 C}}^{\hat{g}}\right) \cong\left(5^{2} \cdot\left(5^{2}: 2\right)\right) \cdot\left(2 \times \Omega_{5}(5)\right)$;
- $\operatorname{Aut}\left(V_{\Lambda_{11 A}}^{\hat{g}}\right) \cong \Omega_{4}^{-}(11) .2$;
- $\operatorname{Aut}\left(V_{\Lambda_{23 A}}^{\hat{g}}\right) \cong \Omega_{3}(23) .2$.


## 2. Preliminaries

2.1. Lattices. A lattice means a free abelian group of finite rank with a rational valued, positive-definite symmetric bilinear form $(\cdot \mid \cdot)$. Let $L$ be a lattice with a positive-definite bilinear form $(\cdot \mid \cdot)$. The symbol $O(L)$ denotes the isometry group of $L$. The dual lattice
is defined by $L^{*}=\left\{\alpha \in \mathbb{Q} \otimes_{\mathbb{Z}} L \mid(\alpha \mid L) \subset \mathbb{Z}\right\}$. A lattice is called integral if $(\alpha \mid \beta) \in \mathbb{Z}$ for any $\alpha, \beta \in L$. A lattice is said to be even if $(\alpha \mid \alpha) \in 2 \mathbb{Z}$ for all $\alpha \in L$. If $L$ is even, then $L$ is integral and $L \subset L^{*}$.

Let $g \in O(L)$. We define the fixed-point sublattice $L^{g}$ of $g$ and the coinvariant lattice $L_{g}$ of $L$ associated with $g$ by

\begin{equation*}
L^{g}=\{\alpha \in L \mid g \alpha=\alpha\} \quad \text { and } \quad L_{g}=\left\{\alpha \in L \mid\left(\alpha \mid L^{g}\right)=0\right\} \tag{2.1}
\end{equation*}
$$

respectively.
Let $L$ be an even lattice. The discriminant group $\mathcal{D}(L)$ is defined by $L^{*} / L$, which is a finite abelian group.

Let

$$
\begin{equation*}
q_{L}: \mathcal{D}(L) \rightarrow \mathbb{Q} / \mathbb{Z}, \quad \alpha+L \mapsto \frac{(\alpha \mid \alpha)}{2}+\mathbb{Z} \tag{2.2}
\end{equation*}
$$

Then $q_{L}$ defines a quadratic form on $\mathcal{D}(L)$. The associated bilinear form on $\mathcal{D}(L)$ given by $(\alpha+L \mid \beta+L)=(\alpha \mid \beta)+\mathbb{Z}$ is non-degenerate. Hence $\left(\mathcal{D}(L), q_{L}\right)$ is a non-degenerate quadratic space. An element $x$ of a quadratic space $(V, q)$ is called singular if $x \neq 0$ and $q(x)=0$.

Definition 2.1. Let $p$ be a prime. An integral lattice $L$ is said to be $p$-elementary if $p L^{*} \subset L$.

We recall a result from LS24.
Lemma 2.2. ([LS24, Lemma 2.1]) Let $L$ be an even lattice with a positive-definite bilinear form $(\cdot \mid \cdot)$. If $g$ is a fixed-point free isometry of $L$, then

$$
\left((1-g) L^{*}\right)^{*}=(1-g)^{-1} L
$$

The following Lemma will be used later.
Lemma 2.3. Let $L$ and $g$ be as in Lemma 2.2. Moreover we assume that $(1-g) L^{*} \subset L$. Then we have

$$
n L^{*} \subset L
$$

where $n$ is the order of $g$.
Proof. By the assumption $(1-g) L^{*} \subset L$, it suffices to prove that $n L^{*} \subset(1-g) L^{*}$. This condition is equivalent to $(1-g)^{-1} L \subset(1 / n) L$. Since $g$ is fixed-point free, we see that $1-g$ is non-singular. Moreover, since $(1-g)\left(1+g+\cdots+g^{n-1}\right)=0$, we have $1+g+\cdots+g^{n-1}=0$. Since $(1-g) \sum_{k=1}^{n-1} k g^{k}=-n$ id, we have $(1-g)^{-1}=-1 / n \sum_{k=1}^{n-1} k g^{k}$. Thus we see that $n(1-g)^{-1} L=n\left(-1 / n \sum_{k=1}^{n-1} k g^{k}\right) L \subset L$, which implies that $(1-g)^{-1} L \subset(1 / n) L$.
2.2. Notations of Groups. In this subsection, we describe groups which appear in this paper. Let $G$ be a group. For a subgroup $H$ of $G$, the symbols $N_{G}(H)$ and $C_{G}(H)$ denote the normalizer of $H$ in $G$ and the centralizer of $H$ in $G$, respectively. Let $n$ denote the cyclic group with order $n$. The symbol $D_{n}$ denotes the dihedral group with order $n$. Notations of extraspecial group follow (ATLAS.

According to [Gr02], we explain groups related to orthogonal groups over finite field. Let $F$ be a finite field with $\operatorname{Char}(F) \neq 2$ and let $V$ be a non-degenerate quadratic space over $F$. A subspace $U$ of $V$ is called a totally isotropic subspace of $V$ if the quadratic form vanishes on $U$. The dimension of a maximal totally isotropic subspace of $V$ is called the Witt index of $V$, which is denoted by $m(V)$. Then $V$ is expressed as a form $V=U \oplus W$, where $U$ is a certain $2 m(V)$-dimensional subspace of $V$ called hyperbolic and $W$ is a subspace which contains no singular vector. Let $\operatorname{dim}(V)$ be even. If the above $W$ vanishes, then the quadratic space $V$ is called $(+)$-type. Otherwise, $V$ is called $(-)$-type.

We assume that the Witt index of $V$ is greater than or equal to one. Denote the orthogonal group of the quadratic space $V$ by $\operatorname{GO}(V)$. We use $\Omega(V)$ to denote the commutator subgroup of $\mathrm{GO}(V)$ except for the case when $\operatorname{dim}(V)=4$ and $V$ is of $(+)$ type. Set $\# F=q$. If the dimension of $V$ is odd, $\mathrm{GO}(V)$ and $\Omega(V)$ are also written by $\mathrm{GO}_{2 m+1}(q)$ and $\Omega_{2 m+1}(q)$, respectively. Similarly, if the dimension of $V$ is even, then $\mathrm{GO}(V)$ and $\Omega(V)$ are written by $\mathrm{GO}_{2 m}^{\epsilon}(q)$ and $\Omega_{2 m}^{\epsilon}(q)$, where $\epsilon$ is defined as follows:

$$
\epsilon= \begin{cases}+ & \text { if } V \text { is of }(+) \text {-type } \\ - & \text { if } V \text { is of }(-) \text {-type }\end{cases}
$$

2.3. VOAs, modules and automorphisms. A vertex operator algebra (VOA) $(V, Y, \mathbb{1}, \omega)$ is a $\mathbb{Z}$-graded vector space $V=\bigoplus_{i \in \mathbb{Z}} V_{i}$ over the complex field $\mathbb{C}$ equipped with a linear map

$$
Y(a, z)=\sum_{i \in \mathbb{Z}} a_{i} z^{-i-1} \in(\text { End } V)\left[\left[z, z^{-1}\right]\right], \quad a \in V
$$

the vacuum vector $\mathbb{1} \in V_{0}$ and the conformal vector $\omega \in V_{2}$ satisfying some axioms ( FLM88]).

Let $V$ be a VOA. A linear automorphism $\tau$ of $V$ is called an automorphism of $V$ if the linear automorphism satisfies the following:
(1) $\tau \omega=\omega$;
(2) $\tau Y(v, z)=Y(\tau v, z) \tau$ for all $v \in V$.

The symbol Aut ( $V$ ) denotes the group of all automorphisms of $V$. For an automorphism $\tau$ of $V$, let $V^{\tau}=\{v \in V \mid \tau v=v\}$, which is called the orbifold $V O A$. Then $V^{\tau}$ is a subVOA of $V$.

For a VOA $V$, a $V$-module $\left(M, Y_{M}\right)$ is a $\mathbb{C}$-graded vector space $M=\bigoplus_{i \in \mathbb{C}} M_{i}$ equipped with a linear map

$$
Y_{M}(a, z)=\sum_{i \in \mathbb{Z}} a_{i} z^{-i-1} \in(\text { End } M)\left[\left[z, z^{-1}\right]\right], \quad a \in V
$$

satisfying some conditions ([FHL93]). We often denote a $V$-module ( $M, Y_{M}$ ) by $M$.
Let $V$ be a VOA and let $M$ be an irreducible $V$-module. Then there exists $\varepsilon(M) \in \mathbb{C}$ such that $M=\bigoplus_{m \in \mathbb{Z}_{\geq 0}} M_{\varepsilon(M)+m}$ and $M_{\varepsilon(M)}$ is not trivial. The number $\varepsilon(M)$ is called the conformal weight of $M$. For a VOA $V$, let $\operatorname{Irr}(V)$ denote the set of all isomorphism classes of irreducible $V$-modules. We often identify an element in $\operatorname{Irr}(V)$ with its representative. For irreducible $V$-modules $M_{1}$ and $M_{2}$, under certain assumptions, the fusion rule $M_{1} \boxtimes M_{2}$ is defined as in HL95].

Definition 2.4. ([DLM00]) Let $V$ be a VOA and $\tau \in \operatorname{Aut}(V)$. For a $V$-module $M$, the $\tau$-conjugate ( $M \circ \tau, Y_{M \circ \tau}(\cdot, z)$ ) of $M$ is defined as follows:
(1) $M \circ \tau=M$ as a vector space;
(2) $Y_{M \circ \tau}(a, z)=Y_{M}(\tau a, z)$ for any $a \in V$.

The $\tau$-conjugation defines an action of $\operatorname{Aut}(V)$ on $\operatorname{Irr}(V)$. The following lemma follows by definition.

Lemma 2.5. Let $M, M^{1}, M^{2}$ be $V$-modules and let $\tau \in \operatorname{Aut}(V)$.
(1) If $M$ is irreducible, then so is $M \circ \tau$. In addition, both $M$ and $M \circ \tau$ have the same conformal weight.
(2) Assume that the fusion product is defined on $V$-modules. Then $\left(M^{1} \circ \tau\right) \boxtimes\left(M^{2} \circ \tau\right) \cong$ $\left(M^{1} \boxtimes M^{2}\right) \circ \tau$. Hence $\tau$-conjugation preserves the fusion product.
2.4. Lattice VOAs and their automorphism groups. In this section, we review some facts about lattice VOAs and their automorphism groups from [FLM88, DN99, LY14].

We consider the central extension $\hat{L}$ of $L$ with the commutator map defined by $(\cdot \mid \cdot) \bmod 2$. Let $\operatorname{Aut}(\hat{L})$ be the automorphism group of $\hat{L}$. For $\varphi \in \operatorname{Aut}(\hat{L})$, we define the element $\bar{\varphi} \in \operatorname{Aut}(L)$ by $\bar{\varphi}(\alpha)=\overline{\varphi\left(e^{\alpha}\right)}$ for $\alpha \in L$. We denote $\{\varphi \in \operatorname{Aut}(\hat{L}) \mid \bar{\varphi} \in O(L)\}$ by $O(\hat{L})$

Let $L$ be a positive-definite even lattice with a positive-definite symmetric bilinear form $(\cdot \mid \cdot)$. Let $M(1)$ be the Heisenberg VOA associated with $\mathfrak{h}=\mathbb{C} \otimes_{\mathbb{Z}} L$. Let $\mathbb{C}\{L\}=$ $\bigoplus_{\alpha \in L} \mathbb{C} e^{\alpha}$ be the twisted group algebra such that $e^{\alpha} e^{\beta}=(-1)^{(\alpha \mid \beta)} e^{\beta} e^{\alpha}$ for $\alpha, \beta \in L$. The lattice VOA $V_{L}$ associated with $L$ is defined by $M(1) \otimes \mathbb{C}\{L\}$ ([FLM88]).

For $x \in \mathfrak{h}$, set $\sigma_{x}=\exp \left(-2 \pi \sqrt{-1} x_{(0)}\right) \in \operatorname{Aut}\left(V_{L}\right)$ and let $N\left(V_{L}\right)=\left\langle\exp \left(a_{(0)}\right) \mid a \in\left(V_{L}\right)_{1}\right\rangle$. Then $\sigma_{x}$ is in $N\left(V_{L}\right)$ for $x \in \mathfrak{h}$. We remark that Aut $\left(V_{L}\right)=N\left(V_{L}\right) O(\hat{L})$ ([DN99]).

An element $\phi \in O(\hat{L})$ is called a standard lift of $g \in O(L)$ if $\bar{\phi}=g$ and $\phi\left(e^{\alpha}\right)=e^{\alpha}$ for $\alpha \in L^{g}$. The following lemma can be found in [EMS20, LS20].

Lemma 2.6. Let $g \in O(L)$ and let $\hat{g} \in O(\hat{L})$ be a standard lift of $g$.
(1) Any standard lift of $g$ is conjugate to $\hat{g}$ by an element in Aut $\left(V_{L}\right)$.
(2) If $g$ is fixed-point free or has odd order, then $|\hat{g}|=|g|$.

We have exact sequences, which will be used later.
Theorem 2.7. ([LY14, Theorem 5.15]) Let $L$ be a positive-definite rootless even lattice. Let $g$ be a fixed-point free isometry of $L$ of prime order $p$ and $\hat{g}$ a lift of $g$ in $O(\hat{L})$. Then we have the exact sequences

$$
\begin{gathered}
1 \longrightarrow \operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{p}\right) \longrightarrow N_{\operatorname{Aut}\left(V_{L}\right)}(\langle\hat{g}\rangle) \xrightarrow{\varphi} N_{O(L)}(\langle g\rangle) \longrightarrow 1 ; \\
1 \longrightarrow \operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{p}\right) \longrightarrow C_{\operatorname{Aut}\left(V_{L}\right)}(\hat{g}) \longrightarrow C_{O(L)}(g) \longrightarrow 1 .
\end{gathered}
$$

## 3. Irreducible $V_{L}^{\hat{g}}$-MODules and their conjugates

Let $L$ be a positive-definite even lattice and let $g$ be a fixed-point free isometry of $L$ of prime order $p$. Let $\hat{g} \in O(\hat{L})$ be a standard lift of $g$. By Lemma 2.6, $\hat{g}$ also has order $p$.

In [CM, Mi15], it was proved that the orbifold VOA $V_{L}^{\hat{g}}$ is rational, $C_{2}$-cofinite, selfdual and of CFT-type. Under these conditions, the fusion product can be defined on $V_{L}^{\hat{g}}$-modules.

By [DRX17, any irreducible $V_{L}^{\hat{g}}$-module is a submodule of an irreducible $\hat{g}^{s}$-twisted $V_{L}$-module for some $0 \leq s \leq p-1$. Regarding definition of twisted module, refer to [DRX17.

Definition 3.1. ([LS24, Definition 3.1]) An irreducible $V_{L}^{\hat{g}}$-module is said to be of $\hat{g}^{s}$-type if it is a $V_{L}^{\hat{g}}$-submodule of an irreducible $\hat{g}^{s}$-twisted $V_{L}$-module. In addition, it is said to be of untwisted type (resp. twisted type) if it is of $\hat{g}^{0}$-type (resp. of $\hat{g}^{s}$-type for some $1 \leq s \leq p-1)$.

From here, throughout this section, we assume

$$
\begin{equation*}
(1-g) L^{*} \subset L \tag{3.1}
\end{equation*}
$$

3.1. Irreducible $V_{L}^{\hat{g}}$-modules of untwisted type. In this subsection, we discuss the irreducible $V_{L}^{\hat{g}}$-modules of untwisted type.

Let $\lambda+L \in \mathcal{D}(L)$ and $V_{\lambda+L}=M(1) \otimes \operatorname{Span}_{\mathbb{C}}\left\{e^{\alpha} \mid \alpha \in \lambda+L\right\}$. Then $V_{\lambda+L}$ has an irreducible $V_{L}$-module structure ([FLM88]). Since $(1-g) L^{*} \subset L$, we see that $g(\lambda)+L=$
$\lambda+L$. This implies that $V_{\lambda+L}$ is $\hat{g}$-invariant. Let $\hat{g}_{\lambda+L}$ be the $\hat{g}$-module isomorphism of $V_{\lambda+L}$. For $0 \leq j \leq p-1$, set

$$
\begin{equation*}
V_{\lambda+L}(j)=\left\{v \in V_{\lambda+L} \mid \hat{g}_{\lambda+L}(v)=\exp (2 \pi \sqrt{-1} j / p) v\right\} . \tag{3.2}
\end{equation*}
$$

We recall some lemmas, which will be used later.
Lemma 3.2. ([区-BLS24, Lemma 3.1]) Let $h \in N_{O(L)}(g)$ and let $\hat{h} \in N_{\text {Aut }\left(V_{L}\right)}(\hat{g})$ be a lift of h. Let $\lambda+L \in \mathcal{D}(L)$. As sets of isomorphism classes of irreducible $V_{L}^{\hat{g}}$-modules, we have

$$
\left\{V_{\lambda+L}(j) \circ \hat{h} \mid 0 \leq j \leq p-1\right\}=\left\{V_{h^{-1}(\lambda)+L}(j) \mid 0 \leq j \leq p-1\right\} .
$$

Lemma 3.3. ([|BLS24, Lemma 3.2]) Let $\alpha, \lambda \in L^{*}$ and $0 \leq i, j \leq p-1$. If $(\alpha \mid \lambda) \in j / p+\mathbb{Z}$, then as $V_{L}^{\hat{g}}$-modules,

$$
V_{\lambda+L}(i) \circ \sigma_{(1-g)^{-1} \alpha} \cong V_{\lambda+L}(i-j) .
$$

The following proposition describes the stabilizer of $V_{L}(1)$ and the stabilizer of $\left\{V_{L}(i) \mid\right.$ $0 \leq i \leq p-1\}$.

Proposition 3.4. ([Sh04, Theorem 3.3])
(1) The stabilizer of $V_{L}(1)$ in $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$ is isomorphic to $C_{\text {Aut }\left(V_{L}\right)}(\hat{g}) /\langle\hat{g}\rangle$.
(2) The stabilizer of $\left\{V_{L}(i) \mid 0 \leq i \leq p-1\right\}$ in $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$ is isomorphic to $N_{\mathrm{Aut}\left(V_{L}\right)}(\langle\hat{g}\rangle) /\langle\hat{g}\rangle$.
3.2. Irreducible $V_{L}^{\hat{g}}$-modules of twisted type. In this subsection, we discuss the irreducible $V_{L}^{\hat{g}}$-modules of twisted type. We use the descriptions in [ALY18, Sections 3.2 and 3.3]. Let $1 \leq s \leq p-1$. The irreducible $\hat{g}^{s}$-twisted module $V_{L}^{T}\left[\hat{g}^{s}\right]$ is given by

$$
V_{L}^{T}\left[\hat{g}^{s}\right]=M(1)\left[g^{s}\right] \otimes T
$$

where $M(1)\left[g^{s}\right]$ is the $g^{s}$-twisted free bosonic space and $T$ is an irreducible module for a certain $\hat{g}^{s}$-twisted central extension of $L$.
3.3. Irreducible $V_{L}^{\hat{g}}$-modules and the quadratic form. In this subsection, we summarize the classification of irreducible $V_{L}^{\hat{g}}$-modules and review the quadratic form on $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$. For the irreducible $V_{L}^{\hat{g}}$-modules, we adopt the notation in [La20].

The following theorem describes the structure of $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$.
Theorem 3.5 ([La20, Theorem 5.3]). Let L be a positive-definite even lattice and let $g$ be a fixed-point free isometry of $L$ of odd prime order $p$. Assume that $(1-g) L^{*} \subset L$. Then

$$
\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)=\left\{V_{\lambda+L}\left[\hat{g}^{i}\right](j) \mid \lambda+L \in \mathcal{D}(L), 0 \leq i, j \leq p-1\right\}
$$

where $V_{\lambda+L}\left[\hat{g}^{i}\right](j)$ is an irreducible $V_{L}^{\hat{g}}$-module and we identify $V_{\lambda+L}(j)$ with $V_{\lambda+L}\left[\hat{g}^{0}\right](j)$. In particular, $V_{L}^{\hat{g}}$ has exactly $|\mathcal{D}(L)| p^{2}$ inequivalent irreducible modules. Furthermore, if
the conformal weight of $V_{L}[\hat{g}]$ is in $(1 / p) \mathbb{Z}$, then $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \cong \mathcal{D}(L) \times(\mathbb{Z} / p \mathbb{Z})^{2}$ as abelian groups.

The explicit fusion products are given as follows:

$$
\begin{equation*}
V_{\lambda_{1}+L}\left[\hat{g}^{i_{1}}\right]\left(j_{1}\right) \boxtimes V_{\lambda_{2}+L}\left[\hat{g}^{i_{2}}\right]\left(j_{2}\right)=V_{\lambda_{1}+\lambda_{2}+L}\left[\hat{g}^{i_{1}+i_{2}}\right]\left(j_{1}+j_{2}\right) . \tag{3.3}
\end{equation*}
$$

By the theorem above, $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$ forms a finite abelian group under the fusion product.
Let

$$
\begin{equation*}
q: \operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \rightarrow \mathbb{Q} / \mathbb{Z}, \quad M \mapsto \varepsilon(M) \quad(\bmod \mathbb{Z}) \tag{3.4}
\end{equation*}
$$

The conformal weight of $V_{L}^{\hat{g}}$ is the following.

$$
\varepsilon\left(V_{\lambda+L}\left[\hat{g}^{i}\right](j)\right) \equiv \frac{i j}{p}+\frac{(\lambda \mid \lambda)}{2} \quad(\bmod \mathbb{Z})
$$

Then the form $\langle\mid\rangle: \operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \times \operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \rightarrow \mathbb{Q} / \mathbb{Z}$ associated with $q$ is defined by

$$
\begin{equation*}
\left\langle M^{1} \mid M^{2}\right\rangle=q\left(M^{1} \boxtimes M^{2}\right)-q\left(M^{1}\right)-q\left(M^{2}\right) \quad(\bmod \mathbb{Z}) \tag{3.5}
\end{equation*}
$$

The following theorem describes the structure of the quadratic space.
Theorem 3.6. (EMS20, Theorem 3.4]) $\left(\operatorname{Irr}\left(V_{L}^{\hat{g}}\right), q\right)$ is a non-degenerate quadratic space, that is, the form $\langle\mid\rangle$ is non-degenerate and bilinear.

To examine certain orbits, we will use the following proposition later.
Proposition 3.7. ([LS24, Lemma 3.5]) Let $\alpha \in L^{*}$ and $1 \leq i \leq p-1$. For $0 \leq j \leq p-1$,

$$
V_{L}\left[\hat{g}^{i}\right](j) \circ \sigma_{\left(1-g^{i}\right)^{-1} \alpha} \cong V_{\alpha+L}\left[\hat{g}^{i}\right]\left(j^{\prime}\right),
$$

where $j^{\prime}$ is determined by $i j \equiv p(\alpha \mid \alpha) / 2+i j^{\prime}(\bmod p)$. In particular, all irreducible $V_{L}^{\hat{g}}$-modules of $\hat{g}^{i}$-type with the same conformal weight are conjugate under the action of $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$.

## 4. Construction B associated with codes over $\mathbb{Z}_{p}$

In this section, according to [LS24], we review Construction B associated with codes over $\mathbb{Z}_{p}$.

Let $R_{i}(1 \leq i \leq t)$ be a copy of the root lattice of type $A_{p-1}$. The following is a realization of the root lattice of type $A_{p-1}$ :

$$
\left\{\left(a_{1}, a_{2}, \ldots, a_{p}\right) \in \mathbb{Z}^{p} \mid \sum_{i=1}^{p} a_{i}=0\right\} .
$$

For $1 \leq k \leq p$, we define $v_{k} \in \mathbb{Z}^{p}$ by the vector

$$
(0, \ldots, 0, \stackrel{k}{1}, 0, \ldots, 0)
$$

Set $\alpha_{k}=v_{k}-v_{k+1}$ for $1 \leq k \leq p-1$. Then $\Delta=\left\{\alpha_{k} \mid 1 \leq k \leq p-1\right\}$ is a base of the root system of $A_{p-1}$. Let $\Delta_{+}$be the set of all positive roots with respect to the base $\Delta$. The vector $1 / 2 \sum_{\alpha \in \Delta_{+}} \alpha$ is called the Weyl vector with respect to the base $\Delta$. The Coxeter element with respect to the above base $\Delta$ is defined by the transformation on $\mathbb{Z}^{p}$ :

$$
\left(x_{1}, x_{2}, \ldots, x_{p}\right) \mapsto\left(x_{p}, x_{1}, x_{2}, \ldots, x_{p-1}\right) .
$$

Set $R=R_{1} \perp \cdots \perp R_{t}$. Then $\mathcal{D}(R) \cong \mathbb{Z}_{p}^{t}$. For each $1 \leq i \leq t$, fix the above base $\Delta_{i}$ of the root system $R_{i}(2)$ of type $A_{p-1}$, and set $\Delta=\bigcup_{i=1}^{t} \Delta_{i}$.

Let

$$
\nu: R^{*} \rightarrow R^{*} / R=\mathcal{D}(R) \cong \mathbb{Z}_{p}^{t}
$$

be the canonical surjective map. For a subgroup $C$ of $\mathbb{Z}_{p}^{t}$, let $L_{A}(C)$ denote the lattice defined by

$$
\begin{equation*}
L_{A}(C)=\nu^{-1}(C)=\left\{\alpha \in R^{*} \mid \nu(\alpha) \in C\right\} ; \tag{4.1}
\end{equation*}
$$

we call $L_{A}(C)$ the lattice constructed by Construction $A$ from $C$.
Let $g_{\Delta_{i}} \in O\left(R_{i}\right)$ be the Coxeter element defined by the base $\Delta_{i}$. For $e=\left(e_{i}\right) \in \mathbb{Z}_{p}^{t}$, set

$$
\begin{equation*}
g_{\Delta, e}=\left(\left(g_{\Delta_{1}}\right)^{e_{1}}, \ldots,\left(g_{\Delta_{t}}\right)^{e_{t}}\right) \in O\left(L_{A}(C)\right) \tag{4.2}
\end{equation*}
$$

If $\operatorname{gcd}\left(e_{i}, p\right)=1$ for all $1 \leq i \leq t$, then the map $g_{\Delta, e}$ is fixed-point free.
Set

$$
\begin{equation*}
\chi_{\Delta}=\frac{1}{p}\left(\rho_{\Delta_{1}}, \ldots, \rho_{\Delta_{t}}\right) \in \mathbb{Q} \otimes_{\mathbb{Z}} R \tag{4.3}
\end{equation*}
$$

where $\rho_{\Delta_{i}}$ is the Weyl vector of $R_{i}$ with respect to $\Delta_{i}$.
Let $L_{B}(C)$ be the sublattice of $L_{A}(C)$ defined by

$$
\begin{equation*}
L_{B}(C)=\left\{\alpha \in L_{A}(C) \mid\left(\alpha \mid \chi_{\Delta}\right) \in \mathbb{Z}\right\} \tag{4.4}
\end{equation*}
$$

we call $L_{B}(C)$ the lattice constructed by Construction $B$ from $C$.
Let $\lambda_{0}=0$ and define $\lambda_{l}$ for $1 \leq l \leq p-1$ as follows:

$$
\lambda_{l}=\frac{1}{p}\left((p-l) \sum_{k=1}^{l} v_{k}-l \sum_{k=l+1}^{p} v_{k}\right) .
$$

For $x=\left(x_{i}\right) \in \mathbb{Z}_{p}^{t}$, denote

$$
\begin{equation*}
\lambda_{x}=\left(\lambda_{x_{1}}^{1}, \ldots, \lambda_{x_{t}}^{t}\right) \in R_{1}^{*} \perp \cdots \perp R_{t}^{*}=R^{*} \tag{4.5}
\end{equation*}
$$

where $x_{i}$ is regarded as an element of $\{0, \ldots, p-1\}$.
The following results were proved in [LS24].
Lemma 4.1. ([LS24, Lemma 4.10]) $g_{\Delta, e} \in O\left(L_{B}(C)\right)$ if and only if $\lambda_{e} \in L_{A}(C)^{*}$.
Lemma 4.2. ([LS24, Lemma 4.13]) Let $C$ be a self-orthogonal code over $\mathbb{Z}_{p}$. Then $L_{A}(C)^{*}=L_{A}\left(C^{\perp}\right)$.
5. The structure of the kernel associated with the action of Aut ( $V_{L}^{\hat{g}}$ )

Let $L$ be a positive-definite even lattice and let $g$ be a fixed-point free isometry of $L$ of prime order $p$. In this section, we consider the kernel of the action of $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$ on $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$.

We review the action of $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$ on $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$. By Subsection 2.3, Aut $\left(V_{L}^{\hat{g}}\right)$ acts on $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$ by the conjugate action. Moreover, the action preserves the quadratic form of $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$ as described in Theorem 3.6. Hence we can consider the group homomorphism

$$
\begin{equation*}
\mu: \operatorname{Aut}\left(V_{L}^{\hat{g}}\right) \longrightarrow O\left(\operatorname{Irr}\left(V_{L}^{\hat{g}}\right), q\right) \tag{5.1}
\end{equation*}
$$

We determine the structure of the kernel of $\mu$. The following is a generalization of Sh04, Lemma 3.7].

Theorem 5.1. Let $L$ be a positive-definite rootless even lattice and let $g$ be a fixed-point free isometry of $L$ of prime order $p$. If $(1-g) L^{*} \subset L$, then we have the following exact sequence

$$
1 \longrightarrow A \longrightarrow \operatorname{Ker} \mu \xrightarrow{\tilde{\varphi}} B \longrightarrow 1
$$

where $A=\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{p}\right)$ and $B=\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle$.
Proof. By Theorem [2.7, we have an exact sequence

$$
\begin{equation*}
1 \longrightarrow \operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{p}\right) \longrightarrow C_{\operatorname{Aut}\left(V_{L}\right)}(\hat{g}) /\langle\hat{g}\rangle \stackrel{\tilde{\varphi}}{\longrightarrow} C_{O(L)}(g) /\langle g\rangle \longrightarrow 1 . \tag{5.2}
\end{equation*}
$$

We first determine $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{p}\right) \cap \operatorname{Ker} \mu$. By Lemma 3.3, if $(\alpha \mid \lambda) \in j / p+\mathbb{Z}$ for $\alpha, \lambda \in L^{*}$, then as $V_{L}^{\hat{g}}$-modules,

$$
V_{\lambda+L}(i) \circ \sigma_{(1-g)^{-1} \alpha} \cong V_{\lambda+L}(i-j) .
$$

By Lemma 2.3, $L$ is $p$-elementary. Hence, for any $\alpha, \lambda \in L^{*}$, we have

$$
(\alpha \mid \lambda) \in\{i / p+\mathbb{Z} \mid 0 \leq i \leq p-1\} .
$$

Hence, if $\alpha$ is an element of $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{p}\right) \cap \operatorname{Ker} \mu$, then we have $\alpha \in\left(L^{*}\right)^{*}=L$. Thus we see that $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{p}\right) \cap \operatorname{Ker} \mu \subset\left\{\sigma_{\alpha} \mid \alpha \in(1-g)^{-1} L / L^{*}\right\}$. Conversely, by the proof of [LY14, Theorem 5.15], for $\alpha \in(1-g)^{-1} L / L^{*}, \sigma_{\alpha}$ corresponds to the map defined by $\beta \mapsto(p \alpha \mid \beta) \bmod p$ for $\beta \in L$. Since $p \alpha \in p(1-g)^{-1} L \subset L$, for any twisted
module $V_{\lambda+L}\left[\hat{g}^{i}\right](j)$, we have $V_{\lambda+L}\left[\hat{g}^{i}\right](j) \circ \sigma_{\alpha} \cong V_{\alpha+\lambda+L}\left[\hat{g}^{i}\right](j) \cong V_{\lambda+L}\left[\hat{g}^{i}\right](j)$. Hence, $\sigma_{\alpha}$ fixes all irreducible $V_{L}^{\hat{g}}$-modules of twisted type. Moreover, by Lemma 3.3, we see that $\sigma_{\alpha}$ fixes all irreducible $V_{L}^{\hat{g}}$-modules of untwisted type. Hence we have $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{p}\right) \cap$ $\operatorname{Ker} \mu=\left\{\sigma_{\alpha} \mid \alpha \in(1-g)^{-1} L / L^{*}\right\}$. Note that $\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{p}\right) \cong\left\{\sigma_{\alpha} \mid \alpha \in\right.$ $\left.(1-g)^{-1} L / L^{*}\right\}$.

Next we prove that the map $\tilde{\varphi}$ from $\operatorname{Ker} \mu$ to $B$ is surjective. By Lemma 3.2, for any $\lambda \in L^{*}$ and $0 \leq j \leq p-1$, there exists $0 \leq j^{\prime} \leq p-1$ such that

$$
V_{\lambda+L}(j) \circ \hat{h} \cong V_{h^{-1}(\lambda)+L}\left(j^{\prime}\right),
$$

where $\hat{h} \in C_{\operatorname{Aut}\left(V_{L}\right)}(\hat{g}) /\langle\hat{g}\rangle$ and $\tilde{\varphi}(\hat{h})=h$. Hence, if $\tau \in \operatorname{Ker} \mu$, then for any $\lambda \in \mathcal{D}(L)$, we have $\varphi(\tau)^{-1}(\lambda)-\lambda \in L$, which means that $\varphi(\tau)$ is 1 on $\mathcal{D}(L)$. Thus we have $\tilde{\varphi}(\operatorname{Ker} \mu) \subset B$.

Conversely, let $h \in B$. By Theorem 2.7, we obtain an element $\hat{h}$ of $C_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}(\hat{g})$ such that $\varphi(\hat{h})=h$. By Lemma 3.2, for any $\lambda+L \in \mathcal{D}(L)$, there exists $0 \leq j \leq p-1$ such that

$$
V_{\lambda+L}(0) \circ \hat{h} \cong V_{\lambda+L}(j)
$$

Denote the above $j$ for $\lambda+L \in \mathcal{D}(L)$ by $j_{\lambda+L}$. Then we can define a map $f$ from $\mathcal{D}(L)$ to $\mathbb{Z} / p \mathbb{Z}$ defined by $\lambda+L \mapsto j_{\lambda+L}$. This map $f$ is a group homomorphism. In fact, by Lemma 2.5 (2), we have

$$
\left(V_{\lambda_{1}+L}(0) \boxtimes V_{\lambda_{2}+L}(0)\right) \circ \hat{h} \cong\left(V_{\lambda_{1}+L}(0) \circ \hat{h}\right) \boxtimes\left(V_{\lambda_{2}+L}(0) \circ \hat{h}\right) \text { for } \lambda_{1}, \lambda_{2} \in \mathcal{D}(L)
$$

By (3.3), we have $j_{\lambda_{1}+L}+j_{\lambda_{2}+L}=j_{\left(\lambda_{1}+\lambda_{2}\right)+L}$, which means that the map $f$ is a group homomorphism. By Lemma 2.3, $L$ is $p$-elementary. Hence, we can consider an injective group homomorphism

$$
\mathcal{D}(L) \longrightarrow \operatorname{Hom}\left(L^{*} / L, \mathbb{Z}_{p}\right), \alpha \mapsto p(\alpha \mid \cdot) \bmod p
$$

Moreover, since $\mathcal{D}(L)$ is a finite dimensional vector space over $\mathbb{F}_{p}$, the above group homomorphism is bijective. Thus there exists an element $\beta$ of $\mathcal{D}(L)$ such that $f=$ $-p(\beta \mid \cdot) \bmod p$. Define $\hat{h}_{0}=\sigma_{(1-g)^{-1} \beta} \hat{h}$. By Lemma 3.2, for any $\lambda+L \in \mathcal{D}(L)$, we have

$$
V_{\lambda+L}(0) \circ \hat{h}_{0} \cong V_{\lambda+L}(0)
$$

The orthogonal complement of the subspace of $\left\{V_{\lambda+L}(0) \mid \lambda+L \in \mathcal{D}(L)\right\}$ in $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$ with respect to the bilinear form in (3.5) is $\left\{V_{L}\left[\hat{g}^{i}\right](j) \mid 0 \leq i, j \leq p-1\right\}$, which is preserved by the action of $\hat{h}_{0}$. Since $\hat{h}$ and $\hat{g}$ are commutative, $\hat{h}_{0}$-conjugates of $\hat{g}$-modules are also $\hat{g}$-modules. Hence, by Proposition 3.7, we have

$$
V_{L}[\hat{g}](0) \circ \hat{h}_{0} \cong V_{L}[\hat{g}](0)
$$

By Theorem [3.5, $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$ is generated by $\left\{V_{L}(j), V_{\lambda+L}(0), V_{L}[\hat{g}](0) \mid 0 \leq j \leq p-1, \lambda \in\right.$ $\mathcal{D}(L)\}$. Since the above generators are preserved by the action of $\hat{h}_{0}$, by Lemma 2.5 (2), all elements of $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$ are preserved by the action of $\hat{h}_{0}$. This means that $\hat{h}_{0} \in \operatorname{Ker} \mu$, as desired.

By using Theorem 5.1, we have the following corollary.
Corollary 5.2. Let $L$ be a positive-definite rootless even lattice and let $g$ be a fixed-point free isometry of $L$ of prime order $p$. Let $\mu$ be as in (5.1). If $(1-g) L^{*} \subset L$, then the following sequence is exact

$$
\begin{equation*}
1 \longrightarrow H_{1} / H_{2} \longrightarrow \operatorname{Stab}_{\operatorname{Im} \mu}\left(V_{L}(1)\right) \xrightarrow{\tilde{\varphi}^{\prime}} K_{1} / K_{2} \longrightarrow 1, \tag{5.3}
\end{equation*}
$$

where $H_{1}=\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{p}\right), H_{2}=\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{p}\right), K_{1}=C_{O(L)}(g) /\langle g\rangle$ and $K_{2}=\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle$.

Proof. By Proposition [3.4, we can identify $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)$ with $C_{\operatorname{Aut}\left(V_{L}\right)}(\hat{g}) /\langle\hat{g}\rangle$. Let $\pi_{1}$ be the natural map from $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)$ to $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right) / \operatorname{Ker} \mu$ and let $\pi_{2}$ be the natural map from $K_{1}$ to $K_{1} / K_{2}$. Let $i$ be the inclusion in (5.2) and let $\tilde{\varphi}$ be the surjective map in (5.2). By Theorem 5.1, we see that $\operatorname{Ker}\left(\pi_{1} \circ i\right)=H_{2}$, which means that we have the injection map from $H_{1} / H_{2} \operatorname{to~}_{\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right) / \operatorname{Ker} \mu \text {. Moreover, we }}$ see that $\operatorname{Ker}\left(\pi_{2} \circ \tilde{\varphi}\right) \supset \operatorname{Ker} \mu$, which implies that we have the surjective map $\tilde{\varphi}^{\prime}$ from $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right) / \operatorname{Ker} \mu$ to $K_{1} / K_{2}$. Hence we have the following sequence

$$
\begin{equation*}
1 \longrightarrow H_{1} / H_{2} \longrightarrow \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right) / \operatorname{Ker} \mu \xrightarrow{\tilde{\varphi}^{\prime}} K_{1} / K_{2} \longrightarrow 1 . \tag{5.4}
\end{equation*}
$$

Note that the image of $H_{1} / H_{2}$ is included in $\operatorname{Ker} \tilde{\varphi}^{\prime}$.
Finally, we verify that $\operatorname{Ker} \tilde{\varphi}^{\prime}$ is equal to the image of $H_{1} / H_{2}$. By isomorphism theorems, we have $\# \operatorname{Ker} \tilde{\varphi}^{\prime}=\# \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right) / \# \operatorname{Ker} \mu \cdot \# K_{2} / \# K_{1}=\left(\# H_{1} \# K_{1} / \# H_{2} \# K_{2}\right)$. $\# K_{2} / \# K_{1}=\# H_{1} / \# H_{2}$. Since the image of $H_{1} / H_{2}$ is included in $\operatorname{Ker} \tilde{\varphi}^{\prime}$, we have $\operatorname{Ker} \tilde{\varphi}^{\prime}$ is equal to the image of $H_{1} / H_{2}$. Since $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right) / \operatorname{Ker} \mu \cong \operatorname{Stab}_{\operatorname{Im} \mu}\left(V_{L}(1)\right)$ as groups, we have the desired result.

## 6. structure of $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$ In the case $L=\Lambda_{3 C}, \Lambda_{5 C}, \Lambda_{11 A}$ or $\Lambda_{23 A}$.

Thoughout this section, we consider the structure of automorphism groups of orbifold vertex operator algebras in the cases $L=\Lambda_{3 C}, \Lambda_{5 C}, \Lambda_{11 A}$ or $\Lambda_{23 A}$. To compute the automorphism groups, we use MAGMA in this section ([BCP97]).
6.1. The case $L=\Lambda_{3 C}$. Let $C$ be the code over $\mathbb{Z}_{3}$ with the generator matrix

$$
\left(\begin{array}{ccccccccc}
1 & 1 & 1 & 1 & 1 & 1 & 1 & 1 & 1 \\
1 & 1 & 1 & -1 & -1 & -1 & 0 & 0 & 0 \\
1 & -1 & 0 & 1 & -1 & 0 & 1 & -1 & 0
\end{array}\right) .
$$

This code was given in [LS24, Theorem 7.16].
Remark 6.1. By [LS24, Table 1 in Subsection 4.5], we see that $\Lambda_{3 C} \cong L_{B}(C)$ as lattices and $\mathcal{D}(L) \cong 3^{5}$. Hence, $\Lambda_{3 C}$ is realized by Construction B in Section 4 .

For $e=(1,1,1,1,1,1,1,1,1)$, we consider the fixed-point free isometry $g=g_{\Delta, e}$ of $L$ in Section 4. Note that $g$ is a fixed-point free isometry of $L_{B}(C)$ by Lemma 4.1 and Lemma 4.2.

Set $\mathcal{L}_{3 C}=\{\lambda+L \in \mathcal{D}(L) \mid q(\lambda+L)=0\} \backslash\{L\}$. By using MAGMA, we can count the number of orbits under the action $C_{O(L)}(g) /\langle g\rangle$. Hence we have the following proposition.

Proposition 6.2. $C_{O(L)}(g) /\langle g\rangle$ acts transitively on $\mathcal{L}_{3 C}$.
Let $S_{3 C}$ be the set of all singular vectors in $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$. By Theorem 3.5 and Remark 6.1, we have $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \cong 3^{7}$ as abelian groups. Hence, by Wi09, (3.27)], we have $\# S_{3 C}=3^{6}-1$. Since $\Lambda_{3 C}$ is realized by Construction B and $C_{O(L)}(g) /\langle g\rangle$ acts transitively on $\mathcal{L}_{3 C}$, we can imitate the proof of [BLS24, PROPOSITION 6.5]. Hence we obtain the following proposition.

Proposition 6.3. Aut $\left(V_{L}^{\hat{g}}\right)$ also acts transitively on $S_{3 C}$.
Next, we consider the structure of $\operatorname{Ker} \mu$ in (5.1). By Theorem 5.1, we examine $\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{3}\right)$ and $\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle$. By using MAGMA, we see that $\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{3}\right) \cong 3^{4}$. Define the matrix group $T_{3 C}$ by the following:

$$
\left\{\left.\left(\begin{array}{cccc}
1 & a & b & c \\
0 & f & 0 & d \\
0 & 0 & f & e \\
0 & 0 & 0 & 1
\end{array}\right) \in \mathrm{GL}_{4}\left(\mathbb{F}_{3}\right) \right\rvert\, a, b, c, d, e \in \mathbb{F}_{3}, f \in \mathbb{F}_{3} \backslash\{0\}\right\}
$$

By using MAGMA, we see that $\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} \cong T_{3 C} \cong 3_{+}^{1+4}: 2$ and $\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle \cong 3^{4}: 2$. Combining the obtained results with Theorem 5.1, we have the following proposition.

Proposition 6.4. $\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{3}\right) \cong 3^{4}$ and $\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle \cong$ $3^{4}: 2$. Hence, we have $\operatorname{Ker} \mu \cong 3^{4} .\left(3^{4}: 2\right)$ and $\# \operatorname{Ker} \mu=2 \cdot 3^{8}$.

Next we consider the structure of $\operatorname{Im} \mu$ in (5.1). First we determine the order of Aut $\left(V_{L}^{\hat{g}}\right)$. By using MAGMA, we have $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{3}\right) \cong 3^{9}$ and $\# C_{O(L)}(g) /\langle g\rangle=$ $2^{8} \cdot 3^{8} \cdot 5$. Combining this with Theorem 2.7 and Proposition 3.4, we have the following lemma.

Proposition 6.5. $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{3}\right) \cong 3^{9}$ and $\# C_{O(L)}(g) /\langle g\rangle=2^{8} \cdot 3^{8} \cdot 5$. Hence $\# \operatorname{Stab}_{\text {Aut }\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)=2^{8} \cdot 3^{17} \cdot 5$.

Next, we consider the order of $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$.
Proposition 6.6. \#Aut $\left(V_{L}^{\hat{g}}\right)=2^{11} \cdot 3^{17} \cdot 5 \cdot 7 \cdot 13$. Hence, by Proposition 6.4, we have $\# \operatorname{Im} \mu=2^{10} \cdot 3^{9} \cdot 5 \cdot 7 \cdot 13$.

Proof. By Theorem 3.5 and Remark 6.1, we have $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \cong 3^{7}$ as abelian groups. Combining this with Proposition 6.3 and Proposition 6.5, we have

$$
\# \operatorname{Aut}\left(V_{L}^{\hat{g}}\right)=\# S_{3 C} \# \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)=\left(3^{6}-1\right) \cdot 2^{8} \cdot 3^{17} \cdot 5=2^{11} \cdot 3^{17} \cdot 5 \cdot 7 \cdot 13
$$

To determine the structure of $\operatorname{Im} \mu$, we need to consider $\operatorname{Stab}_{\operatorname{Im} \mu}\left(V_{L}(1)\right)$. By using MAGMA, we see that $C_{O(L)}(g) /\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\}$ is isomorphic to a subgroup of $\mathrm{GO}_{5}(3)$ of index 2 containing -1 , where -1 is the diagonal matrix whose all diagonal entries are -1 . Such a subgroup of $\mathrm{GO}_{5}(3)$ is determined uniquely and is precisely the group $2 \times \Omega_{5}(3)$. Hence we have $C_{O(L)}(g) /\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} \cong 2 \times \Omega_{5}(3)$. By Proposition 6.4 and 6.5, we see that $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{3}\right) / \operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{3}\right) \cong 3^{5}$. Combining these with Corollary 5.2, we have the following proposition.

Proposition 6.7. $\operatorname{Stab}_{\operatorname{Im} \mu}\left(V_{L}(1)\right) \cong 3^{5} .\left(2 \times \Omega_{5}(3)\right)$.
Finally, we determine the structure of $\operatorname{Im} \mu$. Since $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \cong 3^{7}$ as abelian groups, $\operatorname{Im} \mu$ is a subgroup of $\mathrm{GO}_{7}(3)$. By [Wi09], we can compute the order of $\mathrm{GO}_{7}(3)$. Combining this with Proposition 6.6, we see that $\left|\mathrm{GO}_{7}(3): \operatorname{Im} \mu\right|=2$. We summarize our results. The group $\operatorname{Im} \mu$ is a subgroup of $\mathrm{GO}_{7}(3)$ satisfying the following:
(1) $\left|\mathrm{GO}_{7}(3): \operatorname{Im} \mu\right|=2$;
(2) $\operatorname{Im} \mu$ acts transitively on $S_{3 C}$;
(3) The stabilizer of an element in $S_{3 C}$ in $\operatorname{Im} \mu$ is isomorphic to $3^{5} .\left(2 \times \Omega_{5}(3)\right)$.

There exist precisely three subgroups of $\mathrm{GO}_{7}(3)$ of index 2 . These three groups are $\mathrm{SO}_{7}(3), 2 \times \Omega_{7}(3)$ and $\Omega_{7}(3) .2$. By using MAGMA, we see that among the above three groups, there exists only one group which satisfies the condition (2) and (3). The group is $\Omega_{7}(3)$. 2. Combining this with Proposition 6.4, we have the following theorem.

Theorem 6.8. $\operatorname{Aut}\left(V_{\Lambda_{3 C}}^{\hat{g}}\right) \cong\left(3^{4} \cdot\left(3^{4}: 2\right)\right) \cdot\left(\Omega_{7}(3) \cdot 2\right)$.
6.2. The case $L=\Lambda_{5 C}$. This case is similar to the case $L=\Lambda_{3 C}$. Let $C$ be the code over $\mathbb{Z}_{5}$ with the generator matrix

$$
\left(\begin{array}{lllll}
1 & 1 & 1 & 1 & 1 \\
1 & 2 & 4 & 3 & 0
\end{array}\right)
$$

This code was also given in [LS24, Theorem 7.16].
Remark 6.9. By [LS24, Table 1 in Subsection 4.5], we see that $\Lambda_{5 C} \cong L_{B}(C)$ as lattices and $\mathcal{D}(L) \cong 5^{3}$. Hence, $\Lambda_{5 C}$ is also realized by Construction B in Section 4 .

For $e=(1,1,1,1,1)$, we consider the fixed-point free isometry $g=g_{\Delta, e}$ of $L$ in Section 4 . Note that $g$ is a fixed-point free isometry of $L_{B}(C)$ by Lemma 4.1 and Lemma 4.2,

Set $\mathcal{L}_{5 C}=\{\lambda+L \in \mathcal{D}(L) \mid q(\lambda+L)=0\} \backslash\{L\}$. By using MAGMA, we can count the number of orbits under the action $N_{O(L)}(g) /\langle g\rangle$. Hence we have the following proposition.

Proposition 6.10. $N_{O(L)}(g) /\langle g\rangle$ acts transitively on $\mathcal{L}_{5 C}$.
Remark 6.11. By using MAGMA, we see that $C_{O(L)}(g) /\langle g\rangle$ does not act transitively on $\mathcal{L}_{5 C}$. More precisely, the number of orbits is two.

Let $S_{5 C}$ be the set of all singular vectors in $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$. By Theorem 3.5 and Remark 6.9, we have $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \cong 5^{5}$ as abelian groups. Hence, by [Wi09, (3.27)], we have $\# S_{5 C}=$ $5^{4}-1$. Since $\Lambda_{5 C}$ is also realized by Construction B, we can imitate the proof of BLS24, PROPOSITION 6.5]. Hence we obtain the following proposition.

Proposition 6.12. Aut $\left(V_{L}^{\hat{g}}\right)$ also acts transitively on $S_{5 C}$.
Next, we consider the structure of $\operatorname{Ker} \mu$ in (5.1). By Theorem 5.1, we examine $\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{5}\right)$ and $\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle$. By using MAGMA, we have $\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{5}\right) \cong 5^{2}$. Define the matrix group $T_{5 C}$ by the following:

$$
\left\{\left.\left(\begin{array}{ccc}
1 & a & b \\
0 & d & c \\
0 & 0 & 1
\end{array}\right) \in \mathrm{GL}_{3}\left(\mathbb{F}_{5}\right) \right\rvert\, a, b, c \in \mathbb{F}_{5}, d \in\{1,-1\}\right\}
$$

By using MAGMA, we see that $\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} \cong T_{5 C} \cong 5_{+}^{1+2}: 2$ and $\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle \cong 5^{2}: 2$. Combining obtained results with Theorem 5.1, we have the following proposition.

Proposition 6.13. $\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{5}\right) \cong 5^{2}$ and $\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle \cong$ $5^{2}: 2$. Hence, we have $\operatorname{Ker} \mu \cong 5^{2} \cdot\left(5^{2}: 2\right)$ and $\# \operatorname{Ker} \mu=2 \cdot 5^{4}$.

Next we consider the structure of $\operatorname{Im} \mu$ in (5.1). First we determine the order of $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$. By using MAGMA, we have $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{5}\right) \cong 5^{5}$ and $\# C_{O(L)}(g) /\langle g\rangle=$ $2^{4} \cdot 3 \cdot 5^{3}$. Combining this with Theorem 2.7 and Proposition 3.4, we have the following lemma.

Proposition 6.14. $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{5}\right) \cong 5^{5}$ and $\# C_{O(L)}(g) /\langle g\rangle=2^{4} \cdot 3 \cdot 5^{3}$. Hence we have \# $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)=2^{4} \cdot 3 \cdot 5^{8}$.

Imitating the proof of Proposition 6.6, we have the following proposition.
Proposition 6.15. \#Aut $\left(V_{L}^{\hat{g}}\right)=2^{8} \cdot 3^{2} \cdot 5^{8} \cdot 13$. Hence, by Proposition 6.13, we have $\# \operatorname{Im} \mu=2^{7} \cdot 3^{2} \cdot 5^{4} \cdot 13$.

Proof. By Theorem 3.5 and Remark 6.9, we have $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \cong 5^{5}$ as abelian groups. Combining this with Proposition 6.12 and Proposition 6.14, we have

$$
\# \operatorname{Aut}\left(V_{L}^{\hat{g}}\right)=\# S_{5 C} \# \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)=\left(5^{4}-1\right) \cdot 2^{4} \cdot 3 \cdot 5^{8}=2^{8} \cdot 3^{2} \cdot 5^{8} \cdot 13
$$

By using MAGMA, we see that $C_{O(L)}(g) /\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\}$ is isomorphic to a subgroup of $\mathrm{GO}_{3}(5)$ of index 2 containing -1 , where -1 is the diagonal matrix whose all diagonal entries are -1 . Such a subgroup of $\mathrm{GO}_{3}(5)$ is determined uniquely and is precisely the group $2 \times \Omega_{3}(5)$. Hence we have $C_{O(L)}(g) /\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} \cong$ $2 \times \Omega_{3}(5)$. By Proposition 6.13 and 6.14, we see that $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{5}\right) / \operatorname{Hom}(L /(1-$ $\left.g) L^{*}, \mathbb{Z}_{5}\right) \cong 5^{3}$. Combining these with Corollary 5.2, we have the following proposition.

Proposition 6.16. $\mathrm{Stab}_{\operatorname{Im} \mu}\left(V_{L}(1)\right) \cong 5^{3} \cdot\left(2 \times \Omega_{3}(5)\right)$.
Finally, we determine the structure of $\operatorname{Im} \mu$. Since $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \cong 5^{5}$ as abelian groups, $\operatorname{Im} \mu$ is a subgroup of $\mathrm{GO}_{5}(5)$. By Wi09, we can compute the order of $\mathrm{GO}_{5}(5)$. Combining this with Proposition 6.15, we see that $\left|\mathrm{GO}_{5}(5): \operatorname{Im} \mu\right|=2$. We summarize our results. The group $\operatorname{Im} \mu$ is a subgroup of $\mathrm{GO}_{5}(5)$ satisfying the following:
(1) $\left|\mathrm{GO}_{5}(5): \operatorname{Im} \mu\right|=2$;
(2) $\operatorname{Im} \mu$ acts transitively on $S_{5 C}$;
(3) The stabilizer of an element in $S_{5 C}$ in $\operatorname{Im} \mu$ is isomorphic to $5^{3} .\left(2 \times \Omega_{3}(5)\right)$.

There exist precisely three subgroups of $\mathrm{GO}_{5}(5)$ of index 2 . These three groups are $\mathrm{SO}_{5}(5), 2 \times \Omega_{5}(5)$ and $\Omega_{5}(5) .2$. By using MAGMA, we see that among the above three groups, there exists only one group which satisfies the condition (2) and (3). The group is $2 \times \Omega_{5}(5)$. Combining this with Proposition 6.13, we have the following theorem.

Theorem 6.17. Aut $\left(V_{\Lambda_{5 C}}^{\hat{g}}\right) \cong\left(5^{2} \cdot\left(5^{2}: 2\right)\right) \cdot\left(2 \times \Omega_{5}(5)\right)$.
6.3. The case $L=\Lambda_{11 A}$. The following lemma describes the structure of the quadratic space $\mathcal{D}(L)$.

Lemma 6.18. ([LS24, Lemma 7.5]) $(\mathcal{D}(L), q)$ is a non-singular 2-dimensional quadratic space over $\mathbb{F}_{11}$ of (-)-type.

Let $g$ be an automorphism of the Leech lattice which belongs to the conjugacy class 11A. By Theorem 3.5, we see that $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \cong 11^{4}$ as abelian groups. We need to determine which type the quadratic space $\left(\operatorname{Irr}\left(V_{L}^{\hat{g}}\right), q\right)$ has. By Lemma 6.18, the quadratic space $\left(\operatorname{Irr}\left(V_{L}^{\hat{g}}\right), q\right)$ has $(-)$-type. Moreover, by [Wi09, (3.27)], we can count the all singular vectors in $\left(\operatorname{Irr}\left(V_{L}^{\hat{g}}\right), q\right)$. Hence, we have the following proposition.

Proposition 6.19. $\left(\operatorname{Irr}\left(V_{L}^{\hat{g}}\right), q\right)$ is of $(-)$-type. Hence, there are 1220 singular vectors in the quadratic space $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$.

Next, we consider the structure of $\operatorname{Ker} \mu$ in (5.1). By Theorem 5.1, we examine $\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{11}\right)$ and $\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle$. By using MAGMA, we see that both groups are trivial. Hence we have the following proposition.

Proposition 6.20. Ker $\mu$ is trivial. Hence the group homomorphism $\mu$ is injective.
By Proposition 6.20, we see that $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right) \cong \operatorname{Im} \mu \subset \mathrm{GO}_{4}^{-}(11)$. By using MAGMA, we see that $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{11}\right) \cong 11^{2}$ and $C_{O(L)}(g) /\langle g\rangle \cong D_{12}$. Hence we have the following proposition.

Proposition 6.21. $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{11}\right) \cong 11^{2}$ and $C_{O(L)}(g) /\langle g\rangle \cong D_{12}$. Hence we have $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right) \cong 11^{2} \cdot D_{12}$ and \# $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)=2^{2} \cdot 3 \cdot 11^{2}$.

Next we consider the orbit of $V_{L}(1)$. By [LS24, Section 7], there exists $\tau \in \operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$ such that

$$
\begin{equation*}
V_{L}(1) \circ \tau \text { is of twisted type. } \tag{6.1}
\end{equation*}
$$

Let $X_{k, 11 A}=\left\{M \in \operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \mid q(M)=0\right.$ and $M$ is of $\hat{g}^{k}$-type $\}$. Imitating Wi09, (3.27), (3.28)], we can count the number of elements of $X_{k, 11 A}$ for $0 \leq k \leq 10$. Hence we have the following lemma.

Lemma 6.22. $\# X_{0,11 A}=11$ and $\# X_{k, 11 A}=121$ for $1 \leq k \leq 10$.
Combining Lemma 6.22 with (6.1) and Proposition 3.7, we have the following Lemma.
Lemma 6.23. Under the action of $\operatorname{Im} \mu$, \# $\operatorname{Orbit}\left(V_{L}(1)\right) \geq 122$. Hence we have $2 \leq$ $\left|\mathrm{GO}_{4}^{-}(11): \operatorname{Im} \mu\right| \leq 20$.

Proof. By (6.1), we see that $V_{L}(1) \circ \tau$ is of twisted type. Let it be of $\hat{g}^{s}$-type, where $s$ is a positive integer such that $1 \leq s \leq 10$. Moreover, by Proposition 3.7, all irreducible $V_{L^{g}}^{\hat{g}}$ modules of $\hat{g}^{s}$-type with same conformal weight are conjugate under the action of Aut $\left(V_{L}^{\hat{g}}\right)$. By Lemma 6.22, since $\# X_{s, 11 A}=121$, we have $\# \operatorname{Orbit}\left(V_{L}(1)\right) \geq 122$. Hence, we see that $\# \operatorname{Im} \mu \geq 122 \cdot \# \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)$. By Proposition 6.21, we have $\# \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{\theta}}\right)}\left(V_{L}(1)\right)=$ $2^{2} \cdot 3 \cdot 11^{2}$. By [Wi09, (3.32)], since $\# \mathrm{GO}_{4}^{-}(11)=2^{5} \cdot 3 \cdot 5 \cdot 11^{2} \cdot 61$, we have $\mid \mathrm{GO}_{4}^{-}(11):$ $\operatorname{Im} \mu \mid \leq 20$.

By Proposition 6.19, since $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right)$ has 1220 singular vectors, we see that $\# \operatorname{Im} \mu \leq$ $1220 \cdot \# \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)=1220 \cdot 2^{2} \cdot 3 \cdot 11^{2}=\# \mathrm{GO}_{4}^{-}(11) / 2$. This implies that $2 \leq$ $\left|\mathrm{GO}_{4}^{-}(11): \operatorname{Im} \mu\right|$.

Hence $\operatorname{Im} \mu$ is a subgroup of $\mathrm{GO}_{4}^{-}(11)$ satisfying the following:
(1) $2 \leq\left|\mathrm{GO}_{4}^{-}(11): \operatorname{Im} \mu\right| \leq 20$;
(2) The stabilizer of $V_{L}(1)$ in $\operatorname{Im} \mu$ is isomorphic to $11^{2} . D_{12}$.

By using MAGMA, we can verify that there are precisely four subgroups of $\mathrm{GO}_{4}^{-}(11)$ satisfying the condition (1). These groups are $\Omega_{4}^{-}(11), 2 \times \Omega_{4}^{-}(11), \Omega_{4}^{-}(11) .2$ and $\Omega_{4}^{-}(11) .2$. By using MAGMA, two groups of the these $\Omega_{4}^{-}(11) .2$ have the same group structure. Moreover, by using MAGMA, we see that among the four groups, there exist two subgroups satisfying (2). The structure of the groups is $\Omega_{4}^{-}(11) .2$. Combining this with Proposition 6.20, we have the following theorem.

Theorem 6.24. Aut $\left(V_{\Lambda_{11 A}}^{\hat{g}}\right) \cong \Omega_{4}^{-}(11)$. 2. Hence, Aut $\left(V_{\Lambda_{11 A}}^{\hat{g}}\right)$ acts transitivily on all singular vectors in $\operatorname{Irr}\left(V_{\Lambda_{11 A}}^{\hat{g}}\right)$.

Remark 6.25. By [Wi09, (3.57)], since $\Omega_{4}^{-}(11) \cong \operatorname{PSL}_{2}\left(11^{2}\right)$, we have $\operatorname{Aut}\left(V_{\Lambda_{11 A}}^{\hat{g}}\right) \cong$ $\mathrm{PSL}_{2}\left(11^{2}\right) .2$
6.4. The case $L=\Lambda_{23 A}$. Next we consider the case $L=\Lambda_{23 A}$. By [LS24, Section 7], we see that $\mathcal{D}(L) \cong 23$. Let $g$ be an automorphism of the Leech lattice which belongs to the conjugacy class 23A. By Theorem 3.5, we see that $\operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \cong 23^{3}$.

Next, we consider the structure of $\operatorname{Ker} \mu$ in (5.1). By Theorem 5.1, we examine $\operatorname{Hom}\left(L /(1-g) L^{*}, \mathbb{Z}_{23}\right)$ and $\left\{h \in C_{O(L)}(g) \mid h=1\right.$ on $\left.L^{*} / L\right\} /\langle g\rangle$. By using MAGMA, we see that both groups are trivial. Hence we have the following proposition.

Proposition 6.26. Ker $\mu$ is trivial. Hence the group homomorphism $\mu$ is injective.
Hence we see that $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right) \cong \operatorname{Im} \mu \subset \mathrm{GO}_{3}(23)$. By using MAGMA, we can verify that $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{23}\right) \cong 23$ and $C_{O(L)}(g) /\langle g\rangle \cong 2$. Hence we have the following proposition.

Proposition 6.27. $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{23}\right) \cong 23$ and $C_{O(L)}(g) /\langle g\rangle \cong 2$. Hence, we have $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right) \cong 23.2$ and $\# \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)=2 \cdot 23$.

Next we consider the orbit of $V_{L}(1)$. By [LS24, Section 7], there exists $\tau \in \operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$ such that

$$
\begin{equation*}
V_{L}(1) \circ \tau \text { is of twisted type. } \tag{6.2}
\end{equation*}
$$

Let $X_{k, 23 A}=\left\{M \in \operatorname{Irr}\left(V_{L}^{\hat{g}}\right) \mid q(M)=0\right.$ and $M$ is of $\hat{g}^{k}$-type . Imitating Wi09, (3.27), (3.28)], we can count the number of elements of $X_{k, 23 A}$ for $0 \leq k \leq 22$. Hence we have the following lemma.

Lemma 6.28. $\# X_{k, 23 A}=23$ for $0 \leq k \leq 22$.
By imitating the discussion in the case $11 A$, we have the following lemma.
Lemma 6.29. \# $\operatorname{Orbit}\left(V_{L}(1)\right) \geq 24$. Hence, we have that $\left|\mathrm{GO}_{3}(23): \operatorname{Im} \mu\right| \leq 22$.
Proof. Imitating the proof of Lemma 6.23, we have $\# \operatorname{Orbit}\left(V_{L}(1)\right) \geq 24$. By Proposition 6.27, since $\# \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right)=2 \cdot 23$, we see that $\# \operatorname{Im} \mu \geq 24 \cdot \# \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{\hat{~}})}\right.}\left(V_{L}(1)\right)=$ $2^{4} \cdot 3 \cdot 23$. By Wi09, (3.30)], since $\# \mathrm{GO}_{3}(23)=2^{5} \cdot 3 \cdot 11 \cdot 23$, we have $\left|\mathrm{GO}_{3}(23): \operatorname{Im} \mu\right| \leq$ $\# \mathrm{GO}_{3}(23) /\left(2^{4} \cdot 3 \cdot 23\right)=22$.

Hence $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$ is a subgroup of $\mathrm{GO}_{3}(23)$ satisfying the following:
(1) $\left|\mathrm{GO}_{3}(23): \operatorname{Im} \mu\right| \leq 22$;
(2) The stabilizer of $V_{L}(1)$ in $\operatorname{Im} \mu$ is isomorphic to 23.2 .

By using MAGMA, we can verify that there are precisely five subgroups of $\mathrm{GO}_{3}(23)$ satisfying the condition (1). These groups are $\Omega_{3}(23), 2 \times \Omega_{3}(23), \mathrm{SO}_{3}(23), \Omega_{3}(23) .2$ and $\mathrm{GO}_{3}(23)$. By using MAGMA, we see that among these five groups, there are two groups satisfying (2). The groups are $\Omega_{3}(23) .2$ and $\mathrm{GO}_{3}(23)$.

Remark 6.30. By using MAGMA, for $\Omega_{3}(23) .2$ and $\mathrm{GO}_{3}(23)$, we can count the number of the orbits on $23^{3}$. The number of the orbits of $\Omega_{3}(23) .2$ (resp. GO ${ }_{3}(23)$ ) is 2 (resp. $1)$. For the group $\Omega_{3}(23) .2$, the number of elements of each orbit is 264 .

We determine which group $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)$ is. To determine, we first examine the structure of the normalizer $N_{\text {Aut }\left(V_{L}\right)}(\langle\hat{g}\rangle) /\langle\hat{g}\rangle$. By using MAGMA, we see that $N_{O(L)}(\langle g\rangle) /\langle g\rangle \cong 22$. Moreover, by Proposition 6.27, we see $\operatorname{Hom}\left(L /(1-g) L, \mathbb{Z}_{23}\right) \cong 23$. Combining these with Theorem 2.7 and Proposition 3.4, we have the following lemma.

Lemma 6.31. $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(\left\{V_{L}(i) \mid 0 \leq i \leq 22\right\}\right) \cong 23.22$.
By using Lemma 6.31, we have the following lemma.

Lemma 6.32. Under the action of the stabilizer $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{\theta}}\right)}\left(\left\{V_{L}(i) \mid 0 \leq i \leq 22\right\}\right)$ on $\left\{V_{L}(i) \mid 0 \leq i \leq 22\right\}$, we have \# $\operatorname{Orbit}\left(V_{L}(1)\right)=11$.

Proof. By Lemma 6.31, we have $\# \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(\left\{V_{L}(i) \mid 0 \leq i \leq 22\right\}\right)=506$. Since $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(V_{L}(1)\right) \subset \operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(\left\{V_{L}(i) \mid 0 \leq i \leq 22\right\}\right)$, we have $\# \operatorname{Orbit}\left(V_{L}(1)\right)=$ $506 / 46=11$, as desired.

Finally we have the following theorem.
Theorem 6.33. Aut $\left(V_{\Lambda_{23 A}}^{\hat{g}}\right) \cong \Omega_{3}(23)$. 2. Hence, by Remark 6.30, under the action of Aut $\left(V_{\Lambda_{23 A}}^{\hat{g}}\right)$, the set of all singular vectors in $\operatorname{Irr}\left(V_{\Lambda_{23 A}}^{\hat{g}}\right)$ is divided into two orbits which have same number of elements.

Proof. For contradiction, suppose that $\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)=\mathrm{GO}_{3}(23)$. The center of $\mathrm{GO}_{3}(23)$ is $\{1,-1\}$, where -1 is the diagonal matrix whose all diagonal entries are -1 . Since $\left\{V_{L}(i) \mid 0 \leq i \leq 22\right\}$ is a subspace of $\operatorname{Irr}\left(V_{\Lambda_{23 A}}^{\hat{g}}\right)$, the map -1 preserves $\left\{V_{L}(i) \mid 0 \leq i \leq 22\right\}$. Hence we see that -1 is in $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(\left\{V_{L}(i) \mid 0 \leq i \leq 22\right\}\right)$.

On the other hand, by Lemma 6.32, under the action of $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(\left\{V_{L}(i) \mid 0 \leq i \leq\right.\right.$ $22\}$ ), we have \# $\operatorname{Orbit}\left(V_{L}(1)\right)=11$. Since the stabilizer $\operatorname{Stab}_{\operatorname{Aut}\left(V_{L}^{\hat{g}}\right)}\left(\left\{V_{L}(i) \mid 0 \leq i \leq 22\right\}\right)$ has the element -1 and -1 is fixed-point free, its orbits which do not contain the element $V_{L}(0)$ have even number of elements. This is contradiction, and we have the desired result.

Remark 6.34. By $[$ Wi09,,$(3.57)]$, since $\Omega_{3}(23) \cong \operatorname{PSL}_{2}(23)$, we have Aut $\left(V_{\Lambda_{23 A}}^{\hat{g}}\right) \cong \mathrm{PSL}_{2}(23) .2$

## 7. Conclusion

Throughout Section 6, we determined the automorphism groups of the orbifold VOAs. In conclusion, we have the following theorem.

Theorem 7.1. Let $(g, L) \in\left\{\left(3 C, \Lambda_{3 C}\right),\left(5 C, \Lambda_{5 C}\right),\left(11 A, \Lambda_{11 A}\right),\left(23 A, \Lambda_{23 A}\right)\right\}$ and let $\hat{g}$ be a lift of $g$ in Subsection 2.4. Then the automorphism groups of orbifold VOAs $V_{L}^{\hat{g}}$ are following:

- $\left.\operatorname{Aut}\left(V_{\Lambda_{3 C}}^{\hat{g}}\right) \cong\left(3^{4} \cdot\left(3^{4}: 2\right)\right) \cdot\left(\Omega_{7}(3) \cdot 2\right)\right)$;
- $\operatorname{Aut}\left(V_{\Lambda_{5 C}}^{\hat{g}}\right) \cong\left(5^{2} \cdot\left(5^{2}: 2\right)\right) \cdot\left(2 \times \Omega_{5}(5)\right)$;
- $\operatorname{Aut}\left(V_{\Lambda_{11 A}}^{\hat{g}}\right) \cong \Omega_{4}^{-}(11) .2 ;$
- $\operatorname{Aut}\left(V_{\Lambda_{23 A}}^{\hat{g}}\right) \cong \Omega_{3}(23)$. 2 .
